010 JOHN WATT, COMMITTEE CHAIR: Convenes meeting at 1:30 p.m.

027 CINDY BECKER, ASSISTANT DIRECTOR OF EXEC. DEPT.: Submits information

(EXHIBIT A) & speaks about the Executive Dept.

174 REPRESENTATIVE CEDRIC HAYDEN: In downsizing of state government, this is in net people, not in percentage related to population?

180 BECKER: Correct.

184 HAYDEN: But the County and Local is growing radically? Is there a transfer from State to Local?

187 BECKER: I haven't heard of that.

188 REPRESENTATIVE LONNIE ROBERTS, COMMITTEE VICE-CHAIR: Are we talking

about the lowest number per capita? So you may have more people working

than you did a decade ago?

198 BECKER: Responds.

202 ROBERTS: Out of those jobs, how many will not come into the attrition retirement system?

210 BECKER: About 400 to 500.

215 HAYDEN: It is per capita then?

222 WATT: The number you based your figures on is per capita by population?

231 BECKER: Even though number of people in state is growing, the number of state employees are not.

238 WATT: No matter how many employees there are, are they being the most effective they can be?

242 BECKER: That's an important question.

246 WATT: How many programs do we have?

250 BECKER: Not sure off hand.

262 WATT: Can you tell me how much is saved in general fund dollars?

270 BECKER: \$150 million by the combination of efficiencies.

274 WATT: Do you have numbers for AFS, Revenue & Bldg. Codes?

278 BECKER: Yes. -States numbers.

288 ROBERTS: Makes note about training.

297 BECKER: Good point. -Explains what training is taking place.

306 ROBERTS: We pick up the tab on community college study?

308 BECKER: Yes.

311 JOHN RADFORD, ACCOUNTING DIVISION: Explains the project they've been working on. -Compares accounting system to other states. -Oregon ranks 31 in revenue among all 2000 governments in the U.S.A.

370 REPRESENTATIVE DELNA JONES: In terms of personnel how do we rank?

380 RADFORD: I don't have that information.

383 HAYDEN: Out of the top 2000? But there's only 50 states.

386 RADFORD: Yes, but also big counties, Los Angeles, etc. -Explains system.

005 RADFORD: Continues explaining system. -Need to eliminate redundant systems. -Some agencies are instituting other systems.

020 WATT: Which agencies?

025 RADFORD: Corrections and Vocational Rehabilitation. -Explains

034 JONES: What did we do with the money when we had it? Why didn't we do what we should have with it?

043 RADFORD: Responds. -Talks about funding.

093 WATT: We're not on the cutting edge of technology then?

097 RADFORD: Not on the administrative level.

103 WATT: Once the technology is in place . . . will there still be things that just won't need to be done?

114 RADFORD: Responds.

137 WATT: If the accounting systems were in place, how much money do you think we'd be saving?

143 RADFORD: \$19.9 million over 10 years. -Also improves efficiency.

160 HAYDEN: What's the cost benefit ratio?

164 RADFORD: About 14 to \$17 million.

169 JERRY SCHMITZ, INFORMATION SYSTEMS: Submits information (EXHIBIT B).

-Talks about merging departments.

195 WATT: Could you give an example?

197 SCHMITZ: Gives example using Motor Vehicles Division & Law Enforcement Data System. -Speaks on SB 1210.

336 WATT: Why have you waited so long to do this?

340 SCHMITZ: Systems weren't as available.

075 SCHMITZ: Continues his explanation. -Need to change the whole process not just the hardware.

101 WATT: Aren't you more in an advisory role?

103 SCHMITZ: We work plans as well. -Continues explanation.
