TAPE 31, SIDE A

006 REPRESENTATIVE JOHN WATT, COMMITTEE CHAIR: Convenes meeting at 1:33 p.m. as a subcommittee. -Rep. Jones is excused.

(Tape 31, Side A) HB 2376 - Reduction in allotments.

038 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains HB 2376.

071 MIKE MARSH, EXEC. BUDGET AND MANAGEMENT: Submits written testimony (EXHIBIT A) in opposition to HB 2376. -Points out his problems with the bill.

113 WATT: Closes hearing on HB 2376. -Opens hearing on HB 2496.

(Tape 31, Side A) HB 2496 - Out of State Travel

116 SEXTON: Explains HB 2496. -Submits information (EXHIBITS B & C).

166 CINDY BECKER, EXEC. DEPT.: Submits proposed amendments and handouts (EXHIBITS D & E) about HB 2496. -Explains handouts. -Notes frequent flyer information.

220 WATT: Why wouldn't we be successful in negotiating for that?

223 $\,$ BECKER: The state isn't a big enough customer. –Two airlines are willing to work with us.

239 WATT: This information says four airlines will work with us. -If we were to only allow flying on airlines that allowed the state to get the frequent flyer

benefits, what would happen?

268 BECKER: We might not be able to get the lowest fares.

282 ANN VECCHI, AWAY TRAVEL: United is the most used carrier. At least 80% of the time.

291 REPRESENTATIVE CEDRIC HAYDEN: How long are frequent flyer vouchers good for?

296 VECCHI: A couple years.

320 WATT: Why aren't proposed sanctions in these amendments?

325 BECKER: Responds.

334 REPRESENTATIVE MICHAEL PAYNE: Will employees be compensated when they have to spend weekends away, etc.?

345 BECKER: Responds.

357 HAYDEN: Are the employees authorized hotel rooms and per diem, etc.?

365 BECKER: Yes.

377 PAYNE: Will they be forced to stay over weekends?

388 BECKER: Not to my knowledge.

394 REPRESENTATIVE FRED GIROD: Will anything in these amendments change priorities on out of state travel?

400 BECKER: Responds.

435 LARRY LARGE, HIGHER EDUCATION: Submits handout (EXHIBIT F) on HB 249 6.

TAPE 32, SIDE A

033 LARGE: Explains handout. -Explains planning. -Explains B.A.R.C.

080 REPRESENTATIVE LONNIE ROBERTS, COMMITTEE VICE-CHAIR: Who is ultimately responsible?

085 LARGE: The Chancellor. -Speaks about frequent flyer miles.

135 MELINDA GRIER: Federal government says that any benefits must be used by the people that received the grant (for the grant).

150 WATT: Does the federal government outline what the sanctions would be for defaulting on that?

165 GRIER: No.

170 LARGE: Continues. -There's not as big a gain from frequent flyer miles as assumed.

200 GIROD: Why do you go on out of state trips at all?

210 LARGE: Submits additional handout (EXHIBIT G). -Details what out of state travel is done.

260 WATT: Notes that the reason for this legislation is to reduce costs and to make sure agencies are accountable for costs.

292 PAYNE: Shouldn't we spend money on education instead of travel?

310 LARGE: Responds.

352 RALPH GROENER: In support of HB 2496. -Gives examples of the benefits. -Cut as much as possible and use it elsewhere.

TAPE 31, SIDE B

058 WATT: Responds when asked that the committee could conceivably eliminate out of state travel. -The more information we get, the better.

072 GIROD: Any solution will require decentralization.

080 MARI ANNE GEST, O.P.E.U.: In support of reducing out of state travel. -Some people need to travel, though. -Submits written testimony (EXHIBIT H). -HB 2496 needs an amendment that compensates employees for weekends and other lost time.

130 SEXTON: Asks for clarification.

135 GEST: Responds.

138 WATT: Closes hearing on HB 2496. -Opens work session on HB 2496.

(Tape 31, Side B) WORK SESSION - HB 2496

150 WATT: Asks about the additional workloads that HB 2496 would cause and maintaining accountability.

157 LARGE: Informally suggests changes: -Page 2, line 5 after the 3rd word, insert "paid for by state dollars."

175 BECKER: Should say "it's a policy of the state that travel awards earned while conducting state business, notwithstanding any other contracts with the federal government or anybody else, go to the state . . ."

189 LARGE: Clarifies expectations of management. Is an honor system acceptable?

196 BECKER: We'd make sure the agencies are complying. Some
sort of internalNeed to actprofessionally.Need to act

217 WATT: The honor system shouldn't be a problem, but you say it will

just cause another level of bureaucracy.

222 LARGE: We'd like to figure out a way to do this, and there would be penalties for violations. We don't want to spend more money than can be recovered, though.

259 GIROD: It doesn't go far enough into restricting out of state travel.

267 JOHNSON: We should ask the Chair to go to Ways & Means and ask that all general fund out of state travel be restricted unless with proven need (responsibility of their job).

291 WATT: Notes page 1, line 23.

295 JOHNSON: We need to say "don't send anybody." 315 BECKER: Out of state travel should be a last resort. -Notes telecommunications is more advantageous as is bringing someone in instead of sending lots of people out.

333 WATT: Notes sub. 5, page 2, line 18. -Addresses sub 2.

360 LARGE: Notes concern in language.

378 KATHLEEN BEAUFAIT: Asks for clarification. -Put in something to the effect of "except as required by specific contractual provisions, condition precedent to the receipt of federal or other grant."

388 LARGE: Fine.

389 WATT: Where would we insert that?

393 BECKER: It would say: "Except as otherwise required as a prerequisite to receive federal or other funds."

427 PAYNE: All out of state travel paid for by the state should be prohibited. That would eliminate general fund payments for it. -Under 1-A.

463 REPRESENTATIVE DAVE MCTEAGUE: That's basically what this amendment already says.

487 WATT: I agree.

TAPE 32, SIDE B

031 WATT: I'd like to recommend the committee consider these amendments as they are now and come back next legislative session for a progress report.

035 GIROD: I think we should go forward with the bill. -I also favor sending a letter to Ways & Means.

044 WATT: Calls attention to page 2, lines 3 and 4. -Add a sub D that would state: "Each agency shall make every effort possible to minimize employee's time spent on out of state travel." -Sub 2, line 7 : "Except as otherwise required as a prerequisite to receive federal or other funds." -I would like to move this. It would go to LC and to fiscal and then come back. 061 HAYDEN: When you say federal or other funds is "Other funds" capitalized with a big "O"? That means non-general funds. 065 WATT: That's the intent, but I don't know if it needs to be capitalized. 070 MOTION: REP. ROBERTS moves to accept amendments to LC 1868. 074 PAYNE: Could there be a friendly amendment to minimize employee time spent out of state on travel? 078 WATT: I added that as a sub D, under section 1, page 2, line 3 and 4. -Will you withdraw your friendly motion? 086 PAYNE: I'd rather have it in #5, but that's okay. -Withdraws friendly motion. VOTE: In a roll call vote, majority votes AYE. AYE: 088 Rep. Girod, Gordly, Johnson, McTeague, Hayden, Vice-Chair Roberts, Chair Watt. NAY: Rep. Payne. ABS: Rep. Jones.

095 WATT: Declares passed. -Closes work session on HB 2496. -Notes a policy change in the committee, with the naming of two subcommittees. -Adjourns meeting at 3:04 p.m.
