1:34 p.m. -Opens work session on HJR 22.

008      ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains HJR 22 and -7  
amendments.

016      REPRESENTATIVE LONNIE ROBERTS: Which committee will have this in  
the interim?

020      WATT: Legislative Counsel Committee.

024      MOTION: Rep. ROBERTS moves HJR 22 with -7 amendments to the

035 WATT: Closes work session on HJR 22. -Opens work session on HB 2496.

038 SEXTON: Explains HB 2496 with -4 amendments.

084 WATT: Notes that many issues were discussed in previous hearings about HB 2496. -Has become an accountability bill. -Notes that the committee will be watching agencies.

102 REPRESENTATIVE ELDON JOHNSON: Did Legislative Fiscal give any indication of reductions that might apply to agencies because of this?

106 SEXTON: No. -Difficult to determine at this time.

115 JOHNSON: Might be brought up to Ways and Means for consideration.

120 WATT: Yes. Good idea.

124 REPRESENTATIVE MICHAEL PAYNE: Expresses concern for the little amount saved here compared to what is being cut in schools and developmentally disabled programs.

132 MOTION: Rep. ROBERTS moves HB 2496 to the floor with a DO PASS recommendation.

137 VOTE: In a ROLL CALL VOTE, all members present vote AYE. Rep. Jones is EXCUSED.

139 WATT: HB 2496 passes to the floor. Rep. Gordly is the carrier. -Closes work session. -Adjourns at 1:45 p.m.
