012 WAR: Asks for a motion to temporarily suspend committee rules to allow consideration of the measure without a written fiscal & revenue statement. 017 REPRESENTATIVE ELDON JOHNSON: Asks for clariffcation of -1 amendments.

019 REPRESENTATIVE FRED GIROD: Explains that -1 amendments just deletes the language " 1993. " House Commi~e oa Ruks and Reorganization March 26, 1993 - Page 2

026 MOTION: Rep. GIROD moves for temporary suspension of committee rules.

030 WATT: Hearing no objections, so ordered.

032 MOTION: Rep. GIROD moves HCR3 as amended to the floor with a DO PASS recommendation. 034ROBERTS: I was unaware that we had already amended the bill. 035 GIROD: It was done in the subcommittee.

038 JONES: It's my understanding that it must be amended in full committee even though it was amended in the subcommittee. 046 GIROD: Retracts MOTION.

052 MOTION: Rep. GIROD moves that the language " 1993" be deleted from HCR 3.
