264 LUKE: How many teachers will lose jobs in your district in this next contract?

270 PETERSON: 15 by attrition.

273 LUKE: No one will actually retire though?

290 PAYNE: Notes that some members make responsible decisions not to cut education.

102 JANET JACKSON: Speaks in response to Rep. Girod's comments. -Submits written testimony (EXHIBIT J) in opposition to HJR 64.

163 HAYDEN: Is that about \$70,000 a year you get paid then?

177 JACKSON: No.

182 WATT: Notes that what her testimony says is that she has hers and won't give it up, nor does she care about anyone else.

215 JACKSON: About 3.2 percent.

224 LUKE: How many teachers & staff will lose their jobs in your district?

JACKSON: None.

234 NITA STEWART: Submits written testimony (EXHIBIT K) in opposition to HJR 64.

334 LUKE: This resolution does not say teachers are overpaid or not doing their jobs.

380 STEWART: The people of this state will assume that a school pay cut is a solution. It isn't.

406 GIROD: What if the sales tax fails again?

410 STEWART: Responds.

441 JOHNSON: Conditions will be intolerable if we don't get more revenue.

457 WATT: We have to think about a contingency plan.
