008 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Summarizes and explains bill with the -9 and -10 amendments.

064 WATT: Where would that be in the electronic-engrossment?

065 SEXTON: Amend page 3, line 35. Delete "initial". Continues testimony regarding amendments.

091 REP. LONNIE ROBERTS: What's the difference between -9 and -10 amendments?

092 SEXTON: -10 is the Legislative Counsel version. It is the one to work from.

094 MOTION: Rep. Girod moves line 23 of -10 amendments, add "corporation" and delete "licensee". Section 6, subsection 2 delete

"initial". Moves -10 amendments.

VOTE: In a ROLL CALL VOTE, all members present vote AYE. EXCUSED: Rep. Jones and Rep. McTeague

127 MOTION: Rep. Roberts moves HB 2031 as amended to the floor with a DO PASS recommendation.

129 REP. AVEL GORDLY: I will vote no. Don't believe in many of the employment policies that this incorporates.

143 GIROD: I will vote yes on this bill.

150 WATT: Summarizes work completed on this bill.

VOTE: In a ROLL CALL VOTE, voting AYE: Rep. Girod, Hayden, Johnson,

Roberts, Chair Watt. Voting NAY: Rep. Gordly, Payne. EXCUSED: Rep.

167 PAYNE: Gives notice of a possible minority report.

173 WATT: HB 2031 is passed to the Floor as amended. Carrier: Chair Watt - Closes work session on HB 2031. - Opens public hearing on HB 3658.

177 SEXTON: Summarizes and explains HB 3658.

208 REP. JIM WHITTY: Gives testimony in support of HB 3658. - Provides background on bill.

347 JONES: I'm interested in structure of economic department activities.

355 REP. TED CALOURI: Gives testimony is support of HB 3658. -Checked with other states to see how they operate in this area. - Used Transportation Commission as a model.

176 CALOURI: Responds. - There is no downsizing.

199 JONES: How is this different than commission that was just abolished?

206 CALOURI: Responds.

218 JONES: Did you talk to former commissioners and get their input on management?

227 CALOURI: Talked to a former director. Continues testimony.

251 GORDLY: How will women and minorities fit into the scheme of things?

268 CALOURI: Responds.

295 BEYER: Responds. - Opportunities for advocates position. -Concerned with capacity for economic development in rural areas.

329 JONES: Comments on bill. Some departments need more flexibility and some need more management. - Page 8, line 13 speaks on small businesses owned by women and

minorities.

349 DERFLER: This is a good bill that will improve flexibility.

380 CHAR WHITE, LEGISLATIVE ASSISTANT TO REP. CALOURI: Submits and reviews written testimony. (EXHIBIT A). - language to establish commission taken from statute of Transportation Commission. They have the most success. - Governor appoints Commission, but not Director. - Intention is to streamline, give more authority and implement it. - Describes how commissions will be grouped.

000 WHITE: Continues testimony. - Port program stays intact, but is combined into Community and Rural

Development Division. - Explains -1 amendment. (EXHIBIT B)

106 PAYNE: Was there any discussion of financial savings to overlap touriSM with film and video?

134 JUDGE LAURA PRYOR, GILLIAM COUNTY: Gives testimony is support of HB 3658. Discusses frustrations with Economic Development Dept. -Commission should select director. - Feels agency needs stability. -There's a big difference doing economic development in smaller vs.

larger communities.

289 PAYNE: If change made this time, will it have more lasting effects than prior changes.?

298 PRYOR: Responds.

314 JONES: Would like Judge Pryor to stay involved as changes are made.

321 PRYOR: Would be happy to.

325 ALAN WILLIS, OREGON PORTS: Presents testimony on HB 3658. - Concerned about loss of division status.

382 PAGET ENGEN, OREGON PORTS: Presents testimony on HB 3658. - Page 22, line 7 is worrisome to the Port.

426 PETER WILLIAMSON, PORT OF ST. HELENS: Presents written testimony on HB 3658. (EXHIBIT C).
