165 WHITE: Explains that the language could be added in Section 8 beneath lines 16-18 to reflect the progress toward achievement of Oregon

benchmarks.

178 REP. HAYDEN: Discusses concerns with the Oregon Benchmarks.

187 MOTION: REP. D. JONES: Moves to amend between lines 15 and 16 by adding a new Sub (c) to include "progress toward achievement of the

Oregon Benchmarks."

204 WHITE: Continues with explanation of the bill. Discusses the shift of responsibility in Section 16.

214 MCTEAGUE: Asks about program direction. Discusses concerns with the lack of commitment to Legislative direction in the past few years.

245 REP. BEYER: Explains that the program will operate according to the intended language.

256 REP. MCTEAGUE: Comments on the micromanaging that is in the statutes.

272 REP. DERFLER: Explains that the legislature has rule over the statutes, and can direct the policy commission in any direction that they choose

to do.

295 REP. HAYDEN: Asks if the goal is to set up a commission that will strengthen the agency or the administration of commission.

305 REP. DERFLER: Explains the need for stability in the agency in order to foster economic development.

325 WHITE: Discusses section 17. This section authorizes the Commission to adopt rules for Commission duties, functions, and powers.

343 REP. MCTEAGUE: Asks who has the oversight role.

353 REP. BEYER: Explains that this is a function that occurs in other commissions.

366 REP. ROBERTS: Explains that the key to this organization is the commission serving the Governor.

379 WHITE: Explains section 20. Discusses the intent to give the Division the authority to reorganize.

402 REP. ROBERTS: Asks about the touriSMamendment.

420 WHITE: Discusses the deletion of provisions relating to the touriSM division.

460 REP. HAYDEN: Asks if it is the Chair's intention to vote this bill out today.

461 CHAIR WATT: Explains that it is his intention to vote this bill out today.

471 REP. HAYDEN: Discusses concerns with the displaced timber workers.

MOTION: REP. HAYDEN: Moves to amend section 17, line 9, by inserting the words "displaced timber workers," after the word "by". TAPE 82, SIDE B

036 REP. D. JONES: Asks about balancing the displaced timber workers with other issues. Asks if the issues on page 13 are currently in statute in another place, or are they newly developed language.

044 ROBINSON: Explains that the language is just transferred from an existing EDD statute that has been repealed.

048 REP. D. JONES: Explains that this language has already been adopted by the legislature.

063 REP. DERFLER: Discusses the scope of displaced workers.

070 REP. HAYDEN: Explains that he still wants his language in the bill.

079 REP. D. JONES: Objects to the amendment.

085 REP. JOHNSON: Suggests omitting the word timber.

092 CHAIR WATT: Discusses the use of the term structurally unemployed. Discusses a contradiction of terms.

100 REP. HAYDEN: Explains that the timber workers are the most sensitive group in rural Oregon.

112 REP. MCTEAGUE: Suggests adding the words "; and those located in timber dependent communities", after the word "groups".

116 CHAIR WATT: Discusses the language in line two, that already covers that section.

VOTE: 3-3 Motion fails AYE: Hayden, McTeague, Roberts NO: Johnson, Jones, Watt EXCUSED: Girod, Gordly, Payne

134 WHITE: Discusses language clarifications.

MOTION: CHAIR WATT: Moves to amend the bill by restoring the

deleted language suggested by Ms. White.

VOTE: CHAIR WATT: Hearing no objection, the amendment is adopted.

151 WHITE: Discusses the projects eligible for funding.

171 REP. ROBERTS: Asks about the bonding limitations in section 31.
