104 CONCANNON: Explains that the -6 amendments were submitted by the proponents. Discusses employment trends. Discusses rationale of the

program.

137 REP. JOHNSON: Asks about the amount of Jobs Programs proposed currently in the Legislature.

151 REP. MCTEAGUE: Asks about the movement of program participants to other employment opportunities.

benefits.

193 NEELY: Explains that the original impact statement did not include the lottery funds, because they were included in a different bill.

200 REP. MCTEAGUE: Asks what the lottery funds are needed for. 201 NEELY: Explains that the lottery funding is essentially an up front funding piece.

215 REP. MCTEAGUE: Asks about the administration's position on the use of lottery funds.

218 BILL EARLY, PROPONENT OF HB 2459: Explains that the Department and the Administration support the full funding of the Jobs Program.

236 VICE-CHAIR ROBERTS: Asks if Mr. Sheketoff has seen the - 6 amendments.

237 CHUCK SHEKETOFF, OREGON HUMAN RIGHTS COALITION: Explains that he has seen the -6 amendments.
