WORK SESSION ON SB 159 A

005 CHAIR WATT: Explains the materials that need to be covered today. Discusses the process of reviewing the amendments.

024 JOHN DILORENZO: Discusses the -37 amendments. Discusses additions to the amendments. (EXHIBIT A) Explains the reason for the changes.

062 MOTION: REP. PAYNE: Moves to ADOPT the DILORENZO CONCEPTUAL amendments.

VOTE: CHAIR WATT: Hearing no objection the amendments are ADOPTED.

Rep. Baum, Rep. Johnson, and Rep. Roberts are excused.

066 DILORENZO: Explains another conceptual amendment to the -37 amendments. Discusses entitlement of attorney fees.

115 REP. HAYDEN: Asks about the amendments effect on the distinction between private service and public service.

118 HEARN: Explains that he is unclear on the language in the amendment. Continues with explanation of the bill.

130 REP. HAYDEN: Asks about replacement of private income.

139 REP. MILNE: Asks for clarification.

146 CHAIR WATT: Explains that it is conforming language concerning the member, candidate, or a member of the immediate family or household.

Clarifies the language.

164 HEARN: Explains the conforming language. Explains the prohibition of receiving honorarium.

174 REP. HAYDEN: Discusses the distinction in a citizen legislature and a professional legislature.

183 ROLLIE WISB ROCK, OREGON TREASURY DEPARTMENT: Explains that the -33 amendments strike the revolving door provision in the bill.

203 VICE-CHAIR ROBERTS: Asks about the participation of employees in contracts.

206 WISB ROCK: Explains that employees are involved in the negotiating of contracts. Explains that some employees are cleared to sign major

contracts.

218 CHAIR WATT: Asks if the -33 amendments cover other departments, as well.

219 WISB ROCK: Explains that the -33 amendments cover other areas. Continues with explanation of sections 25 through 28.

246 PAUL SNYDER, ASSOCIATED OREGON COUNTIES: Discusses the intent of the bill. Discusses contracting issues.
