PUBLIC HEARING - HB 2790

017 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains HB 2790.

042 BETSY BAILEY, A.O.I.: In support of HB 2790. -Submits written testimony (EXHIBIT A).

151 REPRESENTATIVE AVEL GORDLY: Is this for private business or does it inclue non-profit?

158 BAILEY: Not defined in bill, but it would include non-profit.

160 GORDLY: Do other states use this?

164 BAILEY: California. -City of Visalia, in particular.

169 GORDLY: How long have they done this?

171 BAILEY: Responds.

434 MARI ANNE GEST, OPEU: Submits written testimony (EXHIBIT B) in opposition to HB 2790. -What is this other bill they're talking

about?

454 WATT: Responds.

215 PAYNE: Are the workers paid that whole 70 percent? 218 GEST: I don't know.

222 JONES: I don't see anything that says the commission couldn't be made up with some represented employees.

233 BOTKIN: Responds.

269 WATT: Closes public hearing on HB 2790 -Opens public hearing on HB 2431.

286 JONES: Explains HB 2431.

333 MIKE GREENFIELD, DEPUTY SEC. of STATE: Defers the details of the bill to Jim Manary.

345 JIM MANARY, DEPT. of REVENUE: Gives background on HB 2431. -Submits information (EXHIBIT C)

440 WATT: Has any serious consideration been given to the data-base idea?

450 MANARY: Responds.

TAPE 49, SIDE B

040 MANARY: Continues.

047 JONES: Putting people who are at odds over an issue in a group together results in a good working environment.

068 WATT: Notes that the 'sense of the room' feels pretty good about the idea.

070 MANARY: Continues explanation.

129 WATT: Can the agencies involved electronically communicate now?

133 MANARY: Not efficiently. -Notes other handout (EXHIBIT C).

225 WATT: Closes public hearing on HB 2431. -Opens work session on HB 2431.

WORK SESSION - HB 2431

230 WATT: This has a subsequent referral to Revenue. -We don't want to address some of the issues here then, but let them be addressed in Revenue. -Notes an error.

240 SEXTON: Notes sections that are suggested to be added to the ORS.

250 JONES: Where could we put that in the ORS?

JAN SULLIVAN, CORPORATION DIVISION: We could put it in chapter 56.

283 MOTION: Rep. JONES moves that the amendments as proposed showing LC 904 to HB 2431 be adopted with a correction in section 1, line 6:

change from ORS 305 to ORS 56.

300 WATT: Hearing no objections, so ordered.

310 SULLIVAN: Notes predicted fiscal impact was \$490,000.

336 JONES: What's the relationship with this cost and any savings?

341 SULLIVAN: We would absorb the charges. Any agency printing and distribution would go to us.

348 JONES: What would be the savings?

353 MANARY: Savings in postage. Not sure of the total amount.

384 WATT: Closes work session on HB 2431.

390 PAYNE: Is there a referral to fiscal?

392 WATT: No, to revenue. -Opens work session on HB 3422.

427 WATT: Explains HB 3422.

125 VOTE: In a ROLL CALL VOTE, all members present vote AYE. EXCUSED: Rep. Gordly, Johnson. 133 WATT: Declares HB 3422 passed to full committee. -Rep. Watt is the carrier. -Adjourns at 3:10 p.m.
