114 REPRESENTATIVE DELNA JONES: What is the problem that needs to be solved with the current administration?

150 JONES: You're preventing a problem from happening?

- 077 WATT: Who do you think opposes this bill?

- 087 JONES: How long have you been in CCRC's and have you hired an attorney?
- 090 MACKENZIE: Responds.
- 100 GWEN WHITLOCK, RESIDENT: Submits written testimony (EXHIBIT F) in support of HB 2718.
- 127 WATT: When you considered CCRC's did you ask questions about this?
- 131 WHITLOCK: Not at the time. Now I would.

211 JONES: Does the contract require that unlimited medical service be provided?

217 WHITLOCK: I don't believe so.

JONES: This bill does not make that requirement, either.

227 WHITLOCK: It requires a review and adequate reserves.

233 WATT: What triggered your concern?

238 WHITLOCK: Responds.

246 WATT: You see a 'dark cloud on the horizon'?

251 WHITLOCK: Responds.

257 BRAD BAYLISS, SENIOR ADVOCATE: Submits written testimony (EXHIBIT F) in support of HB 2718.

318 WATT: Why can't we count on all the facilities to have that high level of conscience?

323 BAYLISS: Responds.

333 WATT: Anything specifically that's come to your attention?

336 BAYLISS: Not in this state.

343 SALLY GOODWIN, OREGON ASSOCIATION OF HOMES FOR THE AGING: All of the continuing care facilities in Oregon are non-profit and all are

sponsored by a church organization. -Current law requires reserves.

390 REPRESENTATIVE ELDON JOHNSON: Who do you provide those reports to?

395 GOODWIN: Responds.

403 JONES: All Oregon facilities are non-profit and sponsored by church groups?

405 GOODWIN: Responds.

420 JONES: The charter would indicate what backing there is?

425 GOODWIN: Yes.

430 JOHNSON: What does the church do?

433 GOODWIN: Responds.

442 JOHNSON: Do the churches have anything to do with running the facilities?

447 GOODWIN: Responds.

047 JIM EDWARDS, CHAIR OF THE CCRC COMMITTEE: Gives history of the CCRC program. -In opposition to HB 2718 because the current law is fine. -Reads a letter from Senior Disabled Services Division.

134 JOHNSON: Do those financial records become public?

139 EDWARDS: Responds.

144 WATT: In the ORS, the reserves are required in increments by the year 2000. How many are there now? 152 EDWARDS: Responds.

156 WATT: Are the reports you mentioned submitted to the federal government?

162 EDWARDS: Yes.

164 MAC MCFARLANE, RESIDENT: The system for CCRC's works fine now.

185 WATT: When you entered the CCRC program, did the financial stability concern you?

192 MCFARLANE: No.

202 GENE STUTZMAN, MENONITE VILLAGE: In opposition to HB 2718.

BILL COSB Y, RESIDENT: The system we have already in place is very good. -In opposition to HB 2718.

296 VERA LARSEN, RESIDENT: In opposition to HB 2718. -We have financial stability.

350 WATT: You have no concerns?

356 LARSEN: I knew what I was buying when I moved in.

366 WATT: Do you have any residents that serve on the board?

371 LARSEN: I do, as a full voting member.

376 PAT BROWN, HOLLADAY PARK PLAZA: In opposition to HB 2718.

 $410\,$  MEL MILES, CROWN RESEARCH: Some states hire outside experts to review their CCRC's.

034 MILES: Continues testimony.

JOHNSON: Do you get involved with the financial aspects?

062 MILES: Yes.

064 JOHNSON: What do you see happening?

066 MILES: Responds.

074 JOHNSON: How do you evaluate the financial condition of CCRC's in Oregon?

078 MILES: All but a few are good. Very strong.

092 JOHNSON: Are you comfortable with the current requirements? 094 MILES: Yes.

114 JOHN SCOTT, RESIDENT: In opposition to HB 2718.

157 JONES: Does your group provide access to financial statements?

161 SCOTT: On request from administration.

163 JONES: Have you met the reserves?

166 SCOTT: I'm sure we have.

170 JONES: Have you heard the concerns and tried to address them?

174 SCOTT: Yes.

181 WATT: How long have you been there? Where did you come from?

185 SCOTT: 4 years. Originally from Portland but recently from Arizona.

190 WATT: Did you look around first?

192 SCOTT: Yes. Chose Oregon.

195 WATT: Your facility is known to have large reserves. Do you feel secure?

200 SCOTT: Yes.

JUNE BROUGHT, RESIDENT: I have confidence in the current system. -Our attorney looked over our contract. -In opposition to HB 2718.

235 DAVE BRYANT, RESIDENT: In opposition to HB 2718. -The system works fine as it is.

279 ROBERT DONOHUE, HILLSIDE MANOR: In opposition to HB 2718. -Reads a letter from Vern Jones, President of Hillside Manor Resident's Association.

345 SCOTT FERGUSON: In opposition to HB 2718.

355 MARY ALICE BJORK, INSURANCE DIVISION: We're not aware of any companies that are having problems. -Neutral on HB 2718.

400 JONES: How would you pay for it?

407 BJORK: Responds.

423 THOMAS ERWIN, OREGON INSURANCE CONSUMER ADVOCATE: Comments on the Willamette University study that was cited earlier.

TAPE 35, SIDE A

030 ERWIN: Continues testimony.

087 PAMELA RUONA, S.D.S.D.: We're neutral on HB 2718.

094 JONES: Can you do financial audits?

098 RUONA: Responds. -This bill also eliminates escrow.

171 WATT: Closes public hearing on HB 2718. -Opens public hearing on HB 2031.

PUBLIC HEARING - HB 2031

180 WATT: Explains situation with HB 2031.

223 REPRESENTATIVE FRED GIROD: Explains -8 amendments (EXHIBIT I).

253 WATT: What would satisfy you short of having all that in statute?

259 GIROD: The -8 amendments will do what I want.

266 DON HILLMAN, OREGON STATE FAIR: Responds. -Submits proposed amendments (EXHIBIT J).

300 WATT: Would the State Fair or the contractor be responsible for loss?

308 HILLMAN: The contractor.

320 GIROD: How much did they make last year and how much did you get?

328 HILLMAN: Responds.

331 JONES: How much did you receive?

334 HILLMAN: Responds. -SB 1119 is our suggestion.

358 WATT: How does SB 1119 relate?

363 JONES: Can you resolve this issue and then bring this back to us?

374 HILLMAN: I don't think we can.

385 JONES: You're comfortable to do the racing now, but the amendment only asks you to continue doing the same.

395 HILLMAN: But what if there isn't someone to do it? Then we have to run it.

405 JONES: Will there be a loss in the next two years?

410 HILLMAN: Yes, I believe so.

415 WATT: Is there a way to resolve this without putting the state in jeopardy of having to pay if there's no one to run racing?

437 DAVE NELSON: Responds, concernining a memo.

460 WATT: What memo is that?

467 NELSON: Responds. Submits memo (EXHIBIT K).

TAPE 36, SIDE A

030 NELSON: Continues testimony.

065 WATT: Are you willing to recoup any losses that may come about in the next two years?

077 NELSON: Responds.

081 WATT: So your concern is just from this memo?

085 CLIFF BABBITT, OREGON HORSEMEN'S BENEVOLENT & PROTECTIVE ASSOCIATION: I haven't seen the memo. I don't know. -Submits written testimony (EXHIBIT L).

111 WATT: What we've got here is a failure to communicate.

127 NELSON: Responds.

165 JONES: Is the state fair the same as business?

195 HILLMAN: Notes part of the memo.

217 WATT: There's a solution here somewhere. Am I missing something?

HILLMAN: After 1994 we'd have to pay for running horse racing.

240 WATT: You need to get together and talk this over again.

275 JERRY SCHNEIDER: In support of HB 2031 but against -7 and -8 amendments.

295 PAMELA BARCLAY: The fair should bear in mind that they need to protect all the horse events, not just racing. 327 BABETTE HORNSTEIN: We just need to work this all out together.

369 HILLMAN: Agriculture is important. We understand this.

390 WATT: Closes public hearing on HB 2031. -Adjourns at 4:52 p.m.
