But we didn't know how to do it at the time. 175 JOE CORTRIGHT: Responds. 191 WATT: Would it still use the Attorney General's office? ROBINSON: No. 193 SEXTON: Is it state-aided because of lottery funds still? 196 202 ROBINSON: Responds. 222 WATT: Closes hearing on SB 169 A and goes to work session on SB 169 A. 225 MOTION: REP. PAYNE moves that SB 169 A be sent to full committee with a DO PASS recommendation. VOTE: In a roll call vote, all members present vote AYE. Rep.
