003 REPRESENTATIVE FRED GIROD, SUBCOMMITTEE CHAIR: Convenes meeting at 1:45 p.m. -Opens hearing on HJR 52.

008 REPRESENTATIVE JOHN MEEK: In support of HJR 52.

069 DENNIS WILEY, OREGON PARKS & RECREATION: In support of HJR 52. 071 JOHN GERVAIS: In support of HJR 52.

092 GIROD: Closes hearing on HJR 52. -Opens hearing on HJR 27.

PUBLIC HEARING - HJR 27

103 REPRESENTATIVE LISA NAITO: Submits written testimony (EXHIBIT B) in support of HJR 27.

113 REPRESENTATIVE LONNIE ROBERTS: Didn't we pass a statute to not receive an increase in the same "session" rather than "term?"

120 NAITO: I didn't consider that. This intended to apply to local government, too.

136 ROBERTS: If we raise pay, we should at least wait for an election.

142 GIROD: Would you mind if this was a statute instead of constitutional change?

147 NAITO: Responds.

156 DON HOLDEN: Submits written testimony (EXHIBIT C) in support of HJR 27.

189 GIROD: We will probably change this into a statute instead of a constitutional amendment.

200 BOB CANTINE, ASSOCIATION OF OREGON COUNTIES: Notes ORS 204 .112, requiring compensation commission. -Explains the process of county ordinances in place that are doing this already.

274 GIROD: Could someone that couldn't vote their own salary increase still vote someone else a salary increase?

293 LAURA PRYOR, GILLIAM COUNTY JUDGE: In our county, we don't vote on our own salaries, but do on others.

323 ROBERTS: Is your position the same as other judges in other counties?

330 PRYOR: No. Explains.

340 GIROD: You would be exempt on this then?

344 PRYOR: I'm not sure.

390 CANTINE: That county has a different kind of government.

450 FRED NEAL, MULTNOMAH COUNTY: Submits information (EXHIBIT D) in opposition to HJR 27.

TAPE 14, SIDE A 035 NEAL: It's a waste of time.

057 REPRESENTATIVE DAVE MCTEAGUE: This isn't trying to stop the process.

070 NEAL: Responds.

ROBERTS moves to adopt -5 amendments to HB 2662. VOTE: In a ROLL CALL VOTE, voting AYE: Rep. Roberts, Hayden, Chair Girod. NAY: Rep. McTeague GIROD: -5 amendments are adopted. MOTION: Rep. HAYDEN moves to send HB 2662 to full committee with a DO PASS recommendation as amended. VOTE: In a ROLL CALL VOTE, voting AYE: Rep. Roberts, Hayden, Chair Girod NAY: Rep. McTeague GIROD: HB 2662 is passed to full committee. -Closes work session on HB 2662. -Adjourns meeting at 2:37 p.m.
