050 GIROD: How are you selected to this commission?

051 CASTLE: We're appointed by the governor. -Continues explanation.

103 GIROD: How many regulations would you say are above federal standards?

107 HANSEN: There are seven categories for rules.

126 CASTLE: Continues explanation.

160 GIROD: What check does the federal government have to see if the

rule is within the of the legislation?

174 CASTLE: Responds.

175 REPRESENTATIVE CEDRIC HAYDEN: On what do you base your assumption that, without these rules and agencies, we'd have a worse environmental condition?

030 CASTLE: Continues response.

060 BOB GILBERT, JAMES RIVER CORPORATION: Submits written testimony (EXHIBIT A) in support of HB 2662. -Explains problems with exceedingly stringent rules.

168 GIROD: It wasn't very cost effective?

173 GILBERT: Correct. We need to check on them afterward.

177 GIROD: Do these stringent standards affect employment in this state?

182 GILBERT: Responds.

190 BRUCE ANDERSON, OREGON HOME BUILDERS ASSOCIATION: In support of HB 266 2. -Economic impact and cost is an important issue.

JOE GILLIAM, FEDERATION OF SMALL BUSINESSES: In support of HB 2662. -The court of appeals is not a viable option. -HJR 22 may help a lot, however E.P.A. is another situation.

265 HAYDEN: Do things get worse without a law to prevent it or do they get better? Or is there a compromise?

280 GILLIAM: Responds.

295 HAYDEN: Without governmental regulations, would we go away from those goals or toward them?

302 GILLIAM: Responds.

305 MCTEAGUE: Have you participated in the processes to make these rules?

317 ANDERSON: Responds.

339 GILLIAM: Responds. 361 MCTEAGUE: Do you want an across the board repeal of environmental legislation or do you want to address individual problems?

420 GILLIAM: Responds.

434 MCTEAGUE: We need to see some comparisons on precise issues.

040 ANDERSON: It seems to be intended to examine rulemaking and regulation as a whole.

062 MCTEAGUE: If this legislation passes, could restrictions be put on all of the existing laws without specifically referencing them?

070 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Responds. -The D.E.Q. and E.Q.C. would probably make those decisions.

080 JIM WHITTY, ASSOCIATED OREGON INDUSTRIES: Our intention is not to change laws that have come from the legislature. -Talking about rules (regulations) from agencies like the E.Q.C. -In support of HB 2662.

122 GIROD: Would you be opposed to a compromise position in that all rules be reviewed by the legislature?

127 WHITTY: Responds.

130 MCTEAGUE: It looks like it would repeal a lot of environmental legislation. Tell me one specific example and let someone from the other side argue against it, and do that with all of them.

169 GIROD: Closes public hearing on HB 2662. -Adjourns meeting at 3:16 p.m.
