If there is no subcommittee assignment, the bill is in the full committee and not active. When a bill is voted out of subcommittee, bill is assigned back to the full committee -- that will also be noted

in the calendar. _Water Subcommittee meetings on Tuesday and Thursday will start at 1:00 p.m. _Environment and Energy and Agriculture and Forestry Subcommittee

meetings will start at 1:30 p.m. _The Agriculture and Forestry Subcommittee will start at 3:30 p.m. on
