[--- Unable To Translate Graphic ---] TAPE 13, SIDE A 005 CHAIR BAUM: Calls the meeting to order at 4:12 p.m. Opens work session on HJM2. WORK SESSION - HJM2 007 KATHRYN VAN NATTA, COMMITTEE ADMINISTRATOR: Introduces testimony from Rep. Sam Dominy, dated February 4, 1993 (EXHIBIT A); a letter from

Congressman Peter DeFazio dated February 3, 1993 (EXHIBIT B); and a

letter from Robert Moore, International Longshoremen's & Warehousemen's Union, dated February 4, 1993 (EXHIBIT C) into the record.

018 REP. HOSTICKA: Asks unanimous consent to suspend the rules to allow the testimony to be entered into the record.

020 CHAIR BAUM: Without objection, rules are suspended.

019 REP. DOMINY: Notes that letter from Congressman DeFazio (EXHIBIT B) states that he feels it is important that we pass HJM2 so that Congress will understand the seriousness of the situation.

Reports no negative testimony on HJM2 in subcommittee and subcommittee recommended HJM2 unanimously.

MOTION: REP. DOMINY: Moves adoption of HJM2-3 Amendment, LC

2390, dated February 4, 1993 (EXHIBIT D).

VOTE: Without objection, CHAIR BAUM declares the amendment

adopted.

043 MOTION: REP. DOMINY: Moves HJM2 to the floor, as amended, with a recommendation for adoption.

045 VOTE: In a roll call vote, all members are present and vote AYE.

054 CHAIR BAUM: HJM 2, as amended, is ordered to the floor with a recommendation that it be adopted.

Rep. Dominy and Rep. Fisher will be joint carriers of the bill.

061 CHAIR BAUM: Will review LC drafts one at a time to give members opportunity to register objections. If there are more than four or five objections to any LC draft a roll call vote will be taken.

080 REP. PETERSON: Why are these unidentified LCs coming to us now? 082 CHAIR BAUM: Because the introduction deadline is earlier than in the past.

090 REP. PETERSON: Where do the LCs come from?

092 CHAIR BAUM: Requestor will be identified as the LCs are reviewed.

095 REP. HOSTICKA: It was mentioned by you or the Speaker that when we consider introducing bills and moving legislation, we should be looking at what we think will go all the way through the process. Thinks some

of the drafts will not get through the process, so may object to

introduction on that basis.

110 REP. DOMINY: How would an objection be shown?

112 CHAIR BAUM: An objection would only be recorded if there is a roll call vote.

Reviews LC 313 (EXHIBIT H) introduced at the request of Lanny Meecher, a constituent of Rep. Clarno, which addresses watershed enhancement maintenance projects. Noting no objection, LC 313 will be introduced as a committee bill. Reviews LC 1309 (EXHIBIT I) introduced at the request of Oregonians in Action addressing destination resorts. Noting one objection, LC 1309 will be introduced as a committee bill.

Reviews LC 1758 (EXHIBIT J) which includes training and stabling of livestock with a definition of farm use in statutes, relating to exclusive farm use zones, is at the request of the Horse Council of Oregon.

Noting no objection, LC 1758 will be introduced as a committee bill.

Reviews LC 1897 (EXHIBIT K) which authorizes raising of domestic elk or deer for commercial purposes at the request of Linda Nickerson.

Noting three objections, LC 1897 will be introduced as a committee bill.

Reviews LC 2015 (EXHIBIT L) which modifies procedure for listing of

threatened or endangered species by Fish and Wildlife Commission.

280 REP. JOSI: Feels there is some benefit from shedding additional light on a subject even if the measure does not go all the way through the

process.

191 CHAIR BAUM: Noting two objections, LC  $\,$  2015 is introduced as a committee bill.

Reviews LC 2159 (EXHIBIT M) which requires the Attorney General's office to review agency actions that has taking implications is at the request of West Amazon Basin Landowners Association, Inc.

Noting no objection, LC 2159 is introduced as a committee bill.

Reviews LC 2285 (EXHIBIT N) which imposes a surcharge on fines for conviction of taking wildlife more than one hour prior to or subsequent to the season established by state Fish and Wildlife Department. Fines will go to hunter education programs. Requestor is not known. Without objection, LC 2285 is introduced as a committee bill. Reviews LC 2385-1 (EXHIBIT O) which requires state Fish and Wildlife

Commission to establish system for allocation of hunting tags for

customers of registered outfitters and guides is at the request of Mike Schaffield.

Noting one objection, declares bill introduced.

Reviews LC 2565 (EXHIBIT P) which requires state Fish and Wildlife

Commission to issue a commercial fishing license to individuals who

assist boat license holder and commercial taking of fish, transferrable license in the name of the boat is at the request of O. B. Carder.

Noting no objection, declares bill introduced.

Reviews LC 2600 (EXHIBIT Q) requires payment of fees for application of instream water right certificate.

Noting three objections, LC 2600 is introduced.

LC 2600 is at my request.

Reviews LC 2601 (EXHIBIT R) which would reorganize LCDC.

280 REP. DELL: We are putting up a large stack of bills that will require significant, long, in-depth public hearings where basic policy issues

will be discussed. Is there a way to give a good public forum to the

policy discussion without duplication.

290 CHAIR BAUM: Noting one objection, LC 2601 is introduced.

All bills committee is introducing today will come back to this

committee.

348 MOTION: REP. DOMINY: Moves introduction of LC 2608 (EXHIBIT S), LC 2629 (EXHIBIT T), LC 2630 (EXHIBIT U) en bloc.

350 REP. NORRIS: Reviews 1991 Session bill history.

Asks for explanation of the policy.
