TAPE 41, SIDE A

005 CHAIR BAUM: Calls meeting to order at 12:07 p.m.

We have tentative amendments which will be explained by our drafter, Sue Hanna.

We will then hold the bill over for final passage until 15 minutes before floor session next Tuesday which will be at 3:45, most likely, because we have also been told that we probably have a very likely fiscal impact on this bill. They are trying to rush to get the fiscal impact done. We want it done right, so we are going to hold the bill over, and I don't think there will be an objection to that.

The bill will potentially referred to Appropriations because it has a fiscal and that's the way we do things in this body.

Asks for motion to suspend the rules to allow adoption of amendments in full committee.

035 MOTION: REP. HOSTICKA: Moves to suspend the rules to

allow consideration of technical amendments HB 3661-42 (EXHIBIT B). VOTE: Without objection, Rep. Baum declares the motion adopted and the rules suspended.

036 CHAIR BAUM: Opens work session on HB 3661.

039 SUE HANNA, LEGISLATIVE COUNSEL: Members of the committee should have a document HB 3661-41 (EXHIBIT A).

Explains HB 3661-41 amendments (EXHIBIT A); you had a proposed engrossed 3661 that you were working from and you passed about ten amendments the other day. We engrossed all of those amendments into the proposed engrossed, and that is what the -41s represent - an engrossment of everything you passed out into the proposed engrossed HB 3661. In doing that process, I went over every bit of it, and I noticed that some of the conceptual amendments were a bit incomplete and there were some concepts you passed but the whole thing was not quite there. So we have the -42 amendments (EXHIBIT B). The -42s amend the -41s. One of the things you were doing was paralleling your language when you were talking about farm income. Sometimes you had a tendency to talk about net very early on, and then there was just income halfway through. Then it got consistent to be gross income. In the conceptual amendments we kind of lost a little consistency, so the first thing we did was go back and make those consistent with the gross income. So the whole bill is talking about the same thing. Then you dealt with some dwellings and small scale primary farm land. I think the concept was there and you probably all thought you did exactly what you wanted to do - you just kind of left out a few things - so we put those back in. It didn't lead in with the dwelling, it just said where it could be but it didn't say what could be there. So we have taken care of that. In another instance you are referring to a section and then you went right to the paragraphs but you left out which subsection you were referring to. So that is taken care of. So these are simply clerical clean ups. It's what you were talking about but not exactly what was down on paper. So that is what you have here in the -42s.

You will notice on the -41s you have my initials, SH, you have "EXP". EXP means it is expedited. That is what the copy editors put there when

they glare at me and say you didn't give us enough time to make sure all the tenses in the sentence are parallel and every last thing was taken

care of. It means they are going to keep copy editing this until it

goes to the floor and they will make changes they are allowed to make in form and style. So there might be a few of those tiny changes when it

hits the floor but there will probably be very few who notice them, except the copy editors.

- 090 REP. PETERSON: Will this be fully engrossed by the time it goes to the floor?
- 092 CHAIR BAUM: Yes, particularly if it goes to Appropriations. 093 HANNA: It is fully engrossed now except for the -42s and what happens is Kathryn drops it at the desk, it comes down to us and we

automatically fully engross everything before it goes to the floor.

- 097 REP. FISHER: Why in "b" on -42 do you have the sum of \$20,000 for the last two years two out of the last three years and then change it to "planted in perennials an average of at least \$40,000"?
- 101 CHAIR BAUM: That may be a mistake.
- 102 HANNA: That may be an error. We will have to go back and check on that.
- 103 CHAIR BAUM: I think it is supposed to be \$20,000.
- 104 HANNA: I brought my work copies down here for that.

If you want to make that change now, when you adopt it you can do it.

106 CHAIR BAUM: Members of the committee, there has been a typo noticed on the -42 amendments. On the -42 amendments, on line 20, the \$40,000

figure should have been \$20,000.

Any further comments about the amendment?

Rep. Fisher, would you move that we first amend the -42 amendments on line 20 from the word "\$40,000" to "\$20,000"?

117 MOTION: REP. FISHER: Moves that the "\$40,000" on line 20 of the -42 amendments be changed to "\$20,000".

VOTE: Without objection, Chair Baum declares the motion adopted.

118 MOTION: REP. REPINE: Moves to adopt -42 amendments (EXHIBIT B), as amended to the -41 amendments (EXHIBIT A).

VOTE: Without objection, Chair Baum declares the motion adopted.

125 MOTION: REP. MARKHAM: Moves to adopt HB 3661-41 amendments (EXHIBIT A), as amended by the HB 3661-42 amendments (EXHIBIT B) to

the

proposed engrossed HB 3661.

VOTE: Without objection, Chair Baum declares the motion adopted.

138 CHAIR BAUM: Now the proposal is to have another full committee meeting 15 minutes before floor session on Tuesday, probably 3:45 p.m., to move this bill once we have the revenue impact, the fiscal impact, and T

expect it to be enough that we will have to be considering moving it to Appropriations, not necessarily to my liking, but that will be what

might happen.
