162 REP. PETERSON: I concur with Rep. Hosticka. When the General Fund already has so many demands, we should not be using it for this type of legislation.

164 REP. LUKE: I would like to point out that they will not be spending this money unless there are fires.

166 CHAIR BAUM: Both points are well taken. In the eastern portion of the state, we've probably had enough moisture this year to get us safely

through the summer without any disasters.

168 REP. VanLEEUWEN: I don't think this necessarily increases the cost to the department, but provides insurance for those people who have it.

They assess the charge from those who do not.

170 STEVE JACKY, Assistant State Forester, Department of Forestry: All forestland owners share in the General Fund, which maintains the 45%

level which is currently supporting the landowners during this 1993-93

biennium. This bill would maintain that 45% level.

175 CHAIR BAUM: It is difficult to determine now what those costs might actually be. It depends on the number of fires, the number of claims,

etc.

177 JACKY: That is correct. The length and severity of the fire season actually dictates how much we will use up over a one-year period.

179 REP. VanLEEUWEN: I think I was confusing two bills.

181 REP. MARKHAM: Does the statute contain a maximum amount in the Fire Protection Fund?

182 JACKY: No, there is no maximum. It's essentially associated with the local fire district protection budgets.

restrictive, and I was only able to find six rules, which I have

outlined in my response. Reviews rules.

150 REP. VanLEEUWEN: Are there exemptions allowed for low-income elderly who have no other heat source than their woodstoves?

152 ARKELL: Yes.

163 REP. FISHER: What kinds of emissions are made by shake mills?

164 ARKELL: They produce dust from sawing and convey sawdust by air conveyors through cyclones. They frequently operate in or near

residential or commercial areas, and we receive a number of nuisance

complaints about shake mills from urban dwellers.

191 REP. FISHER: Material handed out yesterday states that the rules allow entry to any property when there is even a suspicion that air or water

pollution or contamination has occurred. It also states that the authority is essential under federal laws to fulfill enforcement obligations under the Clean Air Act. Does that include water pollution?

209 ARKELL: The basic statute under which these would be referenced pertains only to air quality. It does not extend our authority to water quality.

212 REP. FISHER: Yet you include water pollution in your regulations.

216 ARKELL: The underlying statute allows LRAPA to only regulate those matters pertaining to air quality. The statute is structured to refer to "air, water, solid waste," etc. Our authority is similar, but we can only perform our regulatory responsibilities on matters pertaining to air. 240 REP. DOMINY: How long has LRAPA been in existence, and how long have these rules been in place? 241 ARKELL: The Regional Air Pollution Authority has been in existence in its modern incarnation since 1968. The rules outlined in my testimony were adopted more recently. 262 VOTE: REPS. DELL, DOMINY, HOSTICKA, JOSI, LUKE, NORRIS, PETERSON, REPINE and CHAIR BAUM vote AYE. REPS.
