029 CATHERINE FITCH, Committee Administrator: This measure was heard by the Subcommittee on Environment and Energy on May 3, and attempts to correct non-substantive errors or inconsistencies in Oregon's solid waste

management law.

050 MIKE DEWEY, Oregon Waste Systems: The -3 amendments to SB 42 (EXHIBIT A) have been reviewed by the Department of Environmental Quality (DEQ). Senate Bill 42 is intended to make corrections to erroneous material in Oregon statutes dealing with solid waste and to clarify the intent of

the language. Our legal counsel believes that if these amendments are

not adopted, there may possibly be a substantive change in the statute.

The -3 amendments were not offered on the Senate side.

OPENS PUBLIC HEARING ON SB 333 A-ENGROSSED

142 KATHRYN VAN NATTA, Committee Administrator: Senate Bill 333 deals with manufactured dwellings, and was passed in the Senate with a vote of 29 - 0. The measure has no revenue impact, and allows the siting of 4 to 6

mobile homes in the same density as site-built homes. According to the Building Codes Agency, the change could remove some mobile home parks

from regulation. The agency anticipates an insignificant impact on existing staff, and is unable to estimate any potential revenue impact. 171 SEN. BILL DWYER: Testifies in support of SB 333 A-Engrossed. The amended version of the bill does not impact the landlord-tenant relationship in mobile home parks, and allows clusters of this type of affordable housing. 190 REP. JOSI: We passed a bill during the first part of the session which allows mobile homes in certain areas of the city. How does this bill dovetail with that? 197 DON MINER, Oregon Manufactured Homes: This allows more than one home on a particular lot. The bill you're referring to, HB 2835, allows one home per lot. Senate Bill 333 allows the siting of up to six mobile homes without mobile home park standards. Local development standards must still be complied with, but the state requirements for constructing a mobile home park would not have to be complied with. At the same time, those who live in these "clusters" would still receive landlord-tenant protections. 209 CHAIR BAUM: This also only applies in multi-family zones or where there is the ability to have a permitted outright use. 216 MINER: And only if local officials permit it. It only overrides the state requirement regarding mobile home parks. 220 REP. PETERSON: What is the need for this bill? 221 SEN. DWYER: This bill will create affordable housing for people who cannot afford site-built homes. 231 REP. PETERSON: Does this assume that people will buy a lot as well as a manufactured home? 234 SEN. DWYER: Probably not, but this doesn't preclude that from occurring. 238 REP. PETERSON: So this could be like a mini mobile home park, in which all the landlord-tenant laws still apply? 240 SEN. DWYER: Yes. 243 REP. DOMINY: Would this bill allow manufactured homes to be

247 SEN. DWYER: That's right.

placed on land as long as they met codes and standards?

250 REP. DELL: If I wanted to put six mobile homes in a multi-family zone, would city restrictions still apply?

261 MINER: Projects must comply with local comprehensive plans and land-use regulations. As I understand it, this bill is uniquely designed to

take care of elderly housing within Lane County.

282 REP. DELL: Would there be any city regulations regarding the appearance of these homes?

292 SEN. DWYER: Local governments still have input into this process, and the homes must still comply with local comprehensive plans.

306 REP. DELL: Those restrictions would not be in a comprehensive plan.

307 CHAIR BAUM: This addresses multi-family zones, in which apartment complexes and duplexes are allowed. The standards probably won't be the same as for single-family zones. They'll still have to go through the

planning commission process, as is done for apartments and duplexes.

322 SEN. DWYER: Current law says any cluster of over four manufactured homes is a mobile home park.

334 MINER: The only part of the bill which overrides local control is on Line 6 of the bill regarding "the requirements of ORS 446.003 to

446.145." These statutes contain the minimum standards the state

imposes for mobile home parks. Cities can impose different standards if they so choose.

346 JOSI: What's the status of that other bill? 348 MINER: That bill has passed the Senate, and is awaiting the Governor's signature.

350 JOSI: When that bill takes effect, won't that bill affect multi-family zones?

355 SEN. DWYER: No. The definition of a mobile home is still defined as more than four manufactured homes.

363 MINER: That bill also only affected one home on one lot for single-family use.

388 REP. NORRIS: Are we talking about rental units?

392 SEN. DWYER: It could be a group of tenants. There are all kinds of possibilities.

410 REP. VanLEEUWEN: In one of the towns in my district, manufactured homes must meet much more stringent requirements.

005 FLANAGAN: Continues testimony. Bottles and cans purchased in neigHB oring states which do not have a deposit or bottle bill are being brought to Oregon stores. It's virtually impossible for a retailer to

determine whether a container was purchased outside Oregon.

057 REP. FISHER: I didn't know that bottlers could print an Oregon return on cans which are sold somewhere else.

063 FLANAGAN: You don't want to maintain a separate inventory for each state which has a deposit.

067 REP. FISHER: Are there no laws regarding criminal mischief for those who try to sell unmarked cans?

072 FLANAGAN: We don't want to become "bottle police."

077 REP. PETERSON: Currently 96 bottles per person can be returned per day, unless you post a time during which more will be accepted. Do most

stores post that time?

081 FLANAGAN: Current law states that at any time a retailer is open, they must redeem 96 containers. For volumes over that, retailers must post a sign stating when they will accept additional containers.

088 REP. PETERSON: Is the problem with indigents who survive by bringing in cans?

092 FLANAGAN: Not in our experience.

111 REP. LUKE: What's a can worth on the open market?

114 BURNS: Less than one penny.

116 REP. FISHER: Who is actually out a million dollars over two years?

119 BURNS: At this point, Container Recovery, Inc. We have over-redeemed by \$1.2 million.

124 FLANAGAN: It also costs the retailer. We spend \$45,000 annually per store just staffing the redemption area.

OPENS PUBLIC HEARING ON SB 192 A-ENGROSSED 168 FITCH: Senate Bill 192 A-Engrossed was first heard by the Agriculture and Forestry Subcommittee, and addresses the concern that aggregate

removal from streams can destroy salmon habitat.

This bill requires the Division of State Lands (DSL) to conduct a study regarding the relationship between aggregate removal and habitat

destruction. There is a fiscal impact of \$225,000, which is DSL's estimate of that cost study, which is in a decision package in the Governor's recommended budget for DSL. The source of money is the Watershed Health Program revenue committed from lottery dollars. The bill has an emergency clause.

200 SEN. JOYCE COHEN: Testifies in support of SB 192 A-Engrossed. This bill is not a prohibition bill, but insures that critical habitat areas are identified. In the -4 amendments, we have carefully made exemptions for the agricultural community, have narrowed the bill to include the

anadramous species and have used the word "indigenous." This must go

through agency rule-making before permitting begins.

280 REP. NORRIS: This bill was heard in the Subcommittee on Water, not the Subcommittee on Agriculture and Forestry:

296 GARY GUSTAFSON, Director, Division of State Lands: Presents written testimony (EXHIBIT J) in support of SB 192 A-Engrossed.

368 REP. MARKHAM: Does this cover private as well as public bridges?

370 GUSTAFSON: Yes.

393 REP. HOSTICKA: What kind of activities would people be doing to sensitive habitats which are not covered on your list?

418 SEN. COHEN: Perhaps people who want a small gravel business who use a backhoe in a stream bed. These people are not legitimate agriculture

operators.

TAPE 61, SIDE B

019 REP. JOSI: That occurred on the Nehalem River. These people actually went into the river on someone else's property, took over fifty yards of gravel without any fear of reprisal, and literally changed the course of the river.

denied. 096 JILL ZARNOWITZ, Oregon Department of Fish and Wildlife: Provides map of areas in which anadromous salmonids are listed as sensitive, threatened or endangered (EXHIBIT K).

148 REP. LUKE: What stops the fish below Lebanon?

150 ZARNOWITZ: The Fall Chinook don't go high up in the system; they tend to spawn in the lower, "easier" regions of the river. Stream Chinook go on up into the dam.

177 SEN. COHEN: Rule-making will help identify those small affected areas. We only wanted to use this as an example to show you what we expect to

take place.

190 LARRY TROSI, Oregon Farm Bureau: We have been a part of the working group, and have come up with some language which addresses some of the

concerns we had with the bill, which are incorporated in the -4

amendments.

196 ANDY ANDERSON, Executive Vice-President, Oregon Farm Bureau: We were concerned that farmers be able to continue to maintain diversions and

maintain the integrity of streambanks. We believe these amendments will accomplish that.

220 LADD HENDERSON, Santiam Water Control District: The -4 amendments cover our concerns about the maintenance of fish screening structures.

241 CHAIR BAUM: OPENS WORK SESSION ON SB 192 A-ENGROSSED

244 REP. NORRIS: Reads from letter from the Department of Justice distributed at the Water Subcommittee meeting, which states that "the

removal of 50 cubic yards of material does not require a permit from the Division of State Lands." However, they require State Land Board

approval if on a scenic waterway.

254 CHAIR BAUM: There are also different categories of "scenic waterways."

Asks witness Gary Gustafson of the Division of State Lands whether the

program is already in the agency's budget.

336 GUSTAFSON: Yes, it is in the lottery package under SB 755, which has passed the Senate side. It's currently on the House side.

377 REP. LUKE: I'm concerned we're not sending this to Appropriations.

vote. Senate Bill 867 addresses how creditors of a member of a

cooperative benefit from the member's share of past cooperative profits. 087 SANDRA FLICKER, Oregon Rural Electric Cooperative Association: Presents written testimony (EXHIBIT N) in support of SB 867. 094 HENRY C. LORENZEN, Umatilla Electric Cooperative Association: Presents written testimony (EXHIBIT O) in support of SB 867.

170 REP. DELL: Would this also apply to agricultural co-ops?

172 LORENZEN: The marketing of the grain and a farmer's right to receive proceeds from the grain in no way relates to the equity credits.

196 REP. FISHER: A farmer never owes the Grain Growers Association.

205 JOHN McCULLEY, Agricultural Cooperative Council: Those amounts due would be involved in this bill as well. Technically, there is no

difference because they're both cooperatives.

224 REP. DELL: If I am an unsecured creditor, is this a fairness issue?

241 LORENZEN: It's isn't fair that creditors can enjoy the fruits of a member's past cooperative participation when a member can cause a

cooperative to lose money.

274 REP. LUKE: Couldn't you do this through your own by-laws?

276 LORENZEN: In one particular bankruptcy case, the by-law provisions provided for a security interest in equity credits. The bankruptcy

court said that wasn't enough, that it had to be filed in order to be

enforceable.

292 GARY BAUER, Oregon Independent Telephone Association: Testifies in favor of SB 867.

333 REP. LUKE: Does the bill allow you to not give members equity credit if they owe you money? Or does it allow you security interest in a

bankruptcy?

347 LORENZEN: This bill does not allow a co-op to keep the equity credits of a person who is in bankruptcy. It only allows them a security

interest in the equity credits to secure payment of a past-due bill.

For example, if equity credits total \$100,000, and the past-due bill is \$50, the security interest is only to the extent of the past-due bill,

and does not affect any other creditors' interest in those equity credits that would come once the interest of the cooperative and its past- due bill has been satisfied. 361 REP. DELL: What if they are \$100,000 in debt? The co-op can step in and immediately have a secured interest in the \$100,000, which they get to keep?

097 MIKE DEWEY, Oregon Waste Systems: Introduces next witness.

102 DOUG COENEN, Division President and General Manager, Oregon Waste Systems: Presents written testimony (EXHIBIT Q) in support of SB 103 6.

170 REP. LUKE: Will you address the collection of fees from those who dump solid waste in Oregon?

174 DEWEY: In Oregon, there is an out-of-state surcharge imposed under the state guidelines which has nothing to do with this legislation. The

surcharge is currently under litigation. When Seattle's waste comes

into Oregon, they also pay the 85-cent and the 13-cent fee, so they are helping to subsidize this program. The Senate wanted to be assured there would be no lawsuits for these fees. The fee going out is the same as

the fee going in. 195 REP. LUKE: Who filed the suit?

199 DEWEY: Oregon Waste Systems, another landfill in eastern Oregon, and two others.

209 REP. LUKE: Are these fees separate from the tipping fee?

210 DEWEY: Yes.

211 REP. LUKE: So garbage from outside of Oregon pays the tipping fee plus an additional fee?

212 DEWEY: Yes. The total is \$2.25. Eight-five cents of that is the DEQ tipping fee, and 35-cents is Orphan Site fee.

214 REP. LUKE: Where does the additional money go?

215 DEWEY: It goes to DEQ, primarily to regulate the flow of garbage to insure that the Seattle area has a certification program and recycling

that is similar to Oregon's.

224 REP. LUKE: Does DEQ have control over what Seattle does?

225 DEWEY: Yes, in the sense that landfills operated in Oregon cannot accept their waste unless it's been certified that it's equivalent in

terms of recycling programs.

In Washington, they have a front-end fee, and their programs are funded no matter where the waste goes. We think it's important that the waste

generator pay for these fees. Fees are attributable to industrial waste which goes to a landfill that accepts municipal solid waste. However,

if waste is taken to an industrial solid waste landfill, there are no

fees.

The programs we're funding are recycling programs, education programs,

household hazardous waste programs, and grants to local governments. We need to maintain a base to fund these programs, or find a different

mechanism.

309 KRISTIN MITCHELL, Oregon Sanitary Service Institute: Testifies in support of SB 1036 A-Engrossed. All generators of solid waste in Oregon benefit from these solid waste programs, regardless of where their waste is finally disposed.

330 REP. LUKE: Is the lawsuit referred to earlier retroactive?

335 DEWEY: We are collecting and holding the fees. DEQ is not collecting the fees under the present statutes.

341 REP. LUKE: Have they collected fees in the past?

342 DEWEY: Regarding the surcharge, they are not collecting on out-of-state waste. They are collecting the 85-cents and the 13-cents.

362 REP. FISHER: How much does the state subsidize the landfill process? Do they cover every expense? 384 DEWEY: We haven't discussed permit fees, but we pay substantial permit fees to regulate the operation of landfills. DEQ administers that

program to insure we're in compliance with our permits.

430 COENEN: Ninety-eight cents is not the cost for disposal. That's the fee DEQ applies on top of other fees.

443 REP. FISHER: Questions interstate landfill usage in Oregon and Washington.

450 COENEN: Many landfills are being closed down due to new regulations. Transportation systems have vastly improved. The world has gotten

smaller in terms of utilizing solid waste systems on a regional basis.

TAPE 62, SIDE B

040 DEWEY: The question is whether we should continue to fund these programs. Over time, if we continue to have these fairly expensive

programs, we need to insure that we generate money in Oregon, as opposed to having it leave the state.

056 JERRY YUDELSON, Roosevelt Regional Landfill: Testifies in opposition to SB 1036. Lists communities faced with potential landfill closure due to measure.

074 REP. LUKE: I'm not sure where you get your list. Deschutes County is ready to move on another landfill about ten miles out of town.

075 YUDELSON: As of tomorrow, Deschutes County is taking in proposals from companies to perform a solid waste management study for the three

counties. While there is a strong interest in the area you mentioned, that decision has not yet been made. In meetings I've attended, they're actively considering the out-of-state option on a cost basis. The only landfill to benefit from this bill is Oregon Waste Systems. We're a family-run business, whereas they're part of an \$8,000,000,000 multi-national business. DEQ did not ask for this bill. Previous testimony was self-serving. We don't think the bill has a

public policy basis, and this committee should not be used as a forum

for competitive battles between companies.

129 DIANA GODWIN, Regional Disposal Company: Testifies in opposition to SB 1036.

185 REP. LUKE: If Washington sends garbage to your landfill, they've already paid the fee upfront.

187 YUDELSON: For residential wastes, but not industrial wastes.

197 YUDELSON: The DEQ program is well-funded. Oregon is getting money from 700,000 tons of waste from Washington.

238 REP. NORRIS: Requests proof from witness regarding communities which will be adversely affected by bill.

239 YUDELSON: This issue has just come to the fore. We haven't made an all-out effort to inform people.

276 CHAIR BAUM: OPENS WORK SESSION ON SB 1036 A-ENGROSSED

280 BOB DANKO, Department of Environmental Quality: Testifies in support of SB 1036 A-Engrossed. We have leaned on the state of California because

their fee system encourages the export of hazardous wastes. For

300 DANKO: The money would go to the same programs that the existing solid waste disposal fees go to. If a substantial amount of waste left the

state without this bill, we would have a revenue loss.
