045 LARRY SOWA testified that the basic objection behind the bill was to
get landowners, sportsmen, and the Department of Fish and Wildlife all
working together on habitat projects. He does not feel that the changes
made to the bill are major and that the bill and the concept can work
without the income tax credit incentives.

074 RAY BAUM explained that the people who would benefit from the tax
credit have no objections to its removal.

080 VOTE Motion passed 4-0. Ayes: REP. ADAMS, REP. FEDERICI, REP. SHIBLEY,

CHAIR SCHOON. Excused: REP. JONES, REP. WALDEN.

085 CHAIR SCHOON opened the public hearing on HB 2797, which authorizes school districts to market bonds jointly with other school districts or through association to which school districts belong.

099 JOHN MARSHALL testified that some school districts pool their needs in order for those school districts to take advantage of local economies. He likes the idea of pooling for the medium and small districts which have a need to borrow for the short term, before property taxes are collected. This bill represents a the authority for school districts to pool bond issues.

181 CHAIR SCHOON closed the public hearing on HB 2797 and opened the work session on HB 2797.
