He gave a brief history~land issues as related to the Oregon Confederated Tribes of the Coos, Lower Umpqua, and Siuslaw, and also of current issues. The land that would be exempt from property taxes under HB 3288, until it is put into Federal trust, was obtained from Coos County for back taxes. He cites the reasons for this request. He believed the fiscal impact would be only about \$700 a year, which he said was not significant to the State but is to the tribe. His testimony was based on a handout given to the members. Exhibit 1 098 DOUGLAS HUTCHINSON cited a word he believed had been left out of HB 328 8, as follows: On line 11, instead of "land of an Indian or Indian Tribe acquired by gift or without consideration" the language should read "land of an Indian or Indian Tribe acquired by These minutes paraphrase and/or summarize statements made during this meeting. Questions and discussion interspersed 129 CHIEF BILL BRAINARD stated that about 2 million acres had originally been set aside for the tribe in the middle 1800's. Questions and discussion 150 DOUGLAS HUTCHINSON described the process of putting land into the Federal Trust. Questions and discussion 194 DOUGLAS HUTCHINSON explained the Federal Trust, stating that it is

based on a perceived relationship that the Federal Government assumed with the Confederated Tribes around 1832. Almost invariably the Tribes move the land into the Trust to protect themselves from the burden of State taxes and to avail themselves of Federal programs and support. Questions and discussion interspersed 257 DOUGLAS HUTCHINSON discussed the definition of the term "Indian" as related to HB 3288. Between each Indian Nation, there are many differences in this definition, and he mentioned some of these. Questions and discussion with DOUGLAS HUTCHINSON and CHIEF BILL BRAINARD concerning the term "Indian." 326 REP. WHITTY read language changes he believed should occur on page 11 of HB 3288, as follows: "Land acquired by purchase, gift or without consideration by an Indian Tribe is exempt...", suggested by DOUGLAS HUTCHINSON (see meter 098, Tape 60 above). Discussion 369 DOUGLAS HUTCHINSON related that the property purchased by the Confederated Tribes about 1 1/2 years ago. 285 CHAIR BRIAN related that the effective date currently in HB 3288 would not cover the land that was purchased 1 1/2 years ago.
