WORK SESSION ON HB 2456

040 TERRY DRAKE, REVENUE STAFF: Reviews the -2 amendments to HB 2456 (EXHIBIT A). -The bill involves ethanol blended fuels and a ten-year exemption for production.

060 CHAIR BRIAN: Asks Drake about Page 1 Lines 19 and 22 -define the four-year exemption under the amendments.

065 DRAKE: Replies there is a four year time limit to produce ethanol fuels in the plant from beginning of construction to end product.

072 CHAIR BRIAN: We have had some testimony that states a plant only takes 18 months to build. Asks why the law needs to state four years.

078 DRAKE: Replies that there is a two year period of exemption under current law to allow for construction. The staff chose four years arbitrarily.

090 REP. WHITTY: Asks Chair Brian about filing for exemption.  
-Asks why there is a ten-year period of exemption if there is only a four year allowance for production.

092 CHAIR BRIAN: Responds by stating the law allows for extremes.

112 MOTION: REP. GIROD: Moves to ADOPT the -2 amendments to HB 2456 dated 5-11-93.

115 VOTE: CHAIR BRIAN: Hearing no objection, the motion CARRIES. REP. BURTON and CARTER are EXCUSED.

117 MOTION: REP. GIROD: Moves HB 2456 AS AMENDED to the Full Committee with a DO PASS recommendation.

118 VOTE: In a vote, all members present say AYE. REP. BURTON and CARTER are EXCUSED.

119 CHAIR BRIAN: The motion
