Exhibit 1 112 JOE CORTRIGHT compared U.S. wages and productivity to those of other countries. Questions and discussion interspersed 174 JOE CORTRIGHT pointed out that most businesses are small in Oregon, and he defined the term. He gave other Oregon job statistics and talked about trends in other counties.
