005 CHAIR CEASE CALLS MEETING TO ORDER AT 3:15 PM. -Opens work session on HB 3661.

WORK SESSION ON HB 3661

MOTION: Chair Cease moves for reconsideration of vote on HB 3661 for purpose of making an adjustment. VOTE: Hearing no objection the motion is adopted. ACTION: HB 3661A brought back for reconsideration by the committee

008 REP RAY BAUM, House District 58: Presents overview of HB 366 1-A95 (EXHIBIT A).

024 DICK BENNER, LCDC: Presents overview of HB 3661-A95.

058 SEN BUNN: It's important to make the legislative intent clear that since we don't define "road" in this section, "road" in this section is intended to be road in the bill plus Forest Service and BLM roads.

060 SEN COHEN: That's a policy change. Last time we looked at this it did not include Forest Service and BLM roads. -Has this been worked on as part of the final compromise?

SEN. BUNN: It is not a change from the earlier provisions.

SEN. COHEN: It's my understanding we didn't want BLM--

SEN. BUNN: That policy was for determining whether or not your lot was close enough for a lot to be allowed.

SEN. COHEN: Wants to make sure we're not tampering with that piece.

SEN. BUNN: We're not changing the earlier policy. -We have two definitions for road in this bill. -One is 1500 feet, which excludes BLM and Forest Service roads.

SEN. COHEN: Wants to make sure we still have that piece in the bill.

SEN. BUNN: We do. This is the same definition, but specifically adds

BLM and Forest Service for the purposes of using the rectangular

template.

076 ANN SQUIER, Governor's Natural Resources Advisor: As it appears in this bill, it is not modified or referenced to any definition. -It is the clear intent to define it as it is defined in the other part of the bill, but not to limit it by the additional stricture in that

other part of the bill.

085 MOTION: Chair Cease moves -A95 Amendments to HB 3661A. VOTE: Hearing no objections the motion is adopted. ACTION: MOTION ADOPTED.
