NICHOLSON: Many workers are illiterate. The rules described by Mr. Sparks are a start. However, there are so many problems with information dissemination, and the usefulness of the information provided. SPARKS: We are not here to agree or disagree with these problems. Responds to Mr. Nicholson's accusations on enforcement. We are talking about transient operations and they are hard to document. - there is difficulty in timely investigation - there is either too much or not enough protection for farm workers at the federal level, depending on your particular point of view

Probable cause will be enough to hinder an inappropriate entry. 179 CHAIR CEASE: There are different kinds of problems with animals that are inside and those that are outside. - what is the ratio of questions of neglect due to the owner's death or those of out right negligence? 194 ANDERSON: In Multnomah County, questions of protective custody occur two times each day.
