- 236 CHAIR DWYER: I've been advised by people who should know, that this amendment will be fatal to this bill.
- 243 SANDRA BISHOP, WINE INSTITUTE: Testifies in support of the -13 and -14 amendments. Has no problem with -10 amendments. Opposes amendments. Reads from written testimony (EXHIBIT M).
