013 CHAIR DWYER: calls the meeting to order at 3:07. Takes the agenda
items out of order to introduce three bills. Introducing these bills
does not imply endorsement or opposition.

018 CHERIE COPELAND, COMMITTEE ADMINISTRATOR: LC 2291- Allow
property owners to refuse historic property designation. At the
request of

Dennis Goecks, Yamhill County Commissioner. LC 2181 provides for
certification of prefabricated structure inspectors and their
employment, at the request of Sen. Kennemer. LC 2182 creates a
certificate for limited structural plumbing specialty and a license for
limited structural electrician, also at the request of Sen. Kennemer.

027 MOTION: Sen. Kennemer moves the LC drafts be accepted

for introduction as committee bills.

033 CHAIR DWYER: Hearing no objection, SO ORDERED.

(Tape 14, Side A) SB 341 - MODIFIES OFFENSE OF ILLEGAL CONSIGNMENT PRACTICES - WORK SESSION Witness: Cherie Copeland, Committee Administrator

039 CHERIE COPELAND, COMMITTEE ADMINISTRATOR: SB 341 changes the amount of time to pay a consigner for their vehicle by the dealer from thirty days to ten days. There are also proposed amendments submitted by the auto

dealers. The amendments would allow dealer to dealer consignment without transfer of a title. The amendment would also inform consigners that complaints can be directed to the Department of Motor Vehicles.

054 MOTION: Sen. Kennemer moves the amendment.

057 CHAIR DWYER: Hearing no objection, SO ORDERED.

069 MOTION: Sen. Kennemer moves the bill to the floor as amended with a Do Pass recommendation.

VOTE: The motion passes, 4-0, with Sen. Jolin excused.

(Tape 14, Side A) SB 163 - DELETES REGULATION OF SAVINGS ASSOCIATIONS - WORK SESSION Witnesses: Cherie Copeland, Committee Administrator

087 CHERIE COPELAND, COMMITTEE ADMINISTRATOR: This bill removes from the books statutes regulating state chartered savings and loan associations within the state. The only remaining state-chartered savings and loan

will become a federally-chartered savings and loan by the end of March. The Executive Department wants to remove these regulations from the

books so that it basically ends their obligation to respond to approximately 60 inquiries a year from outside the state and from other entities about state regulation of savings and loans. Federally

chartered savings and loans still require state regulation of their branches inside the state, and regulations governing their holidays.

Those two items need to be covered in statute. Legislative Counsel believes those two issues can be covered in the banking regulations without having the banking regulations cover the federal savings and loans.

119 MOTION: Sen. Cease moves to send bill to Senate Committee on Trade and Economic Development (Government Reorganization and Reinvention) with a Do Pass recommendation subject to the proposed amendments.

VOTE: The measure passes 4-0, with Sen. Jolin excused.
