078 JACK CASSELL, ADMINISTRATOR, OREGON TELEPHONE ASSISTANCE PROGRAM, TELECOMMUNICATION DEVICE ACCESS PROGRAM: Gives informational overview

of the two programs. Reads from prepared testimony in support of the

bill (EXHIBIT B).

183 CHAIR DWYER: Why haven't the low income accounts been tapped? Why haven't we been more aggressive in administering the low income program? And, why should we take money from one program, which wasn't used right, and give it to another program?

198 PEG RALSTON, PUBLIC UTILITY COMMISSION: We have actively seeked recipients for the low-income program and only a low number of

people

have accepted the assistance.

214 CHAIR DWYER: I have a problem with spending money for something that it wasn't earmarked for. I want to know how aggressive you actually were.

I'm concerned that there is \$3.5 million out there for low-income people that was never utilized.

230 RALSTON: When we started out we had no idea what the usage was going to be and we just didn't hit those numbers right.

CHAIR DWYER: You levied a lot more money for the deaf program than the low-income program and you say that you don't have enough for the deaf program when I know that there are a lot more low-income people out there than deaf people.

248 SEN. CEASE: Makes comment about assistance program.

267 CHAIR DWYER: Gives personal history with the bill. Before I move this bill, I want to see data about how aggressive the PUC was in pushing

this program.

288 CASSELL: We have been aggressive in the deaf assistance program. I agree, we need to be more aggressive in promoting this low income

program.

310 CHAIR DWYER: If we combine these accounts, what's left for low income?

316 RALSTON: There should be plenty there to support both programs.

330 SEN. CEASE: The access money is in the account which only collects the one cent tax?

337 CHAIR DWYER: That's exactly my point. If we merge the two programs into one, I'm afraid the low-income program will totally lose it's

identity.

345 RALSTON: Would you like a letter describing to you what has been done in the past with the low-income program.

353 CHAIR DWYER: Yes. I'd say something is wrong somewhere.

356 SEN. KENNEMER: The subsidy for the low-income is \$7 per person, what's the subsidy for the deaf program?

363 CASSELL: We have a \$6 million cost for the relay system plus our overhead.

373 SEN. CEASE: I would like to see more information. Gives information about the history of legislative intent. 394 SEN. KENNEMER: It might be appropriate to look at moving the cap. 408 RALSTON: The build up of the balance we have now was caused by the original tax of 15 cents for low-income and 10 cents for the deaf program. TAPE 83, SIDE A 016 SEN. ADAMS: We have to address the issue of compliance with the Americans with Disabilities Act (ADA). 023 CHAIR DWYER: Maybe Ways and Means should deal with it. 032 SEN. CEASE: More information will help. I'm not satisfied at this point. 038 CASSELLS: Explains budget figures in the Governor's budget. More and more individuals are using the low income program. 056 SEN. RASMUSSEN: Can we raise the cap on one, and leave the two programs separate? 067 CASSELLS: I can't answer for the PUC. I would like to see the cap remain where it is. This bill would allow allotments to be changed and leave the cap alone. 088 SEN. CEASE: The legislative cap is 25 cents. Is this other cap you are talking about something set up by the PUC? 092 RALSTON: The cap was lowered by the PUC. 100 SEN. CEASE: The hearing impaired program is in the right place. Maybe the low income program is in the wrong place. 117 RALSTON: Offers to give the committee information. 128 CHAIR DWYER: How did this bill get this far? 132 CASSELLS: The same as what we are doing now. 137 SEN. CEASE: Asks again for information. 142 CHAIR DWYER: I'll give them that opportunity, but at this point I'm not convinced. 147 CASSELLS: Compares Oregon statistics with other states and offers to get the committee more information. We would still have to go to the E-Board for approval to use the \$3 million.
