068 KAREN DELORENZO, BOARD OF ACCOUNTANCY: Testifies in support of the bill. Reads from written testimony (EXHIBIT B).

096 SEN. KENNEMER: If it's not required twice a year, then what's going to happen to access for candidates?

098 DELORENZO: We don't think it will go down to once a year.

103 SEN. KENNEMER: Do you have any objection to keeping the twice a year statute?

110 CHAIR DWYER: How many take the test and how many do you license?

112 DELORENZO: We give the test to 500 candidates. We license 60 CPAs at each board meeting and we have 6 board meetings a year.

265 DELORENZO: They get credit for participating originally.

272 SEN. KENNEMER: As an examiner or reviewed?

274 DELORENZO: As an examiner.

276 SEN. KENNEMER: What is the continuing education requirement for CPAs.

277 DELORENZO: 80 hours every two years.

278 CHAIR DWYER: What's the difference between the review you have to pay for and the one you don't?

279 DELORENZO: The ones offered by the associations are more in-depth.

289 SEN. KENNEMER: Is there a national standard?

296 DELORENZO: Yes. We are also setting up a board to regulate these associations.

306 SEN. KENNEMER: The bill is drafted broad enough that they can regulate which ones will be approved?

308 DELORENZO: Yes 327 RICHARD GAURDLOCK, OREGON ASSOCIATION OF INDEPENDENT ACCOUNTANTS: Testifies in favor of the bill. We originally opposed this bill, but

our concerns were addressed in the House.
