024 CHAIR DWYER: Calls the meeting to order at 3:07 p.m.

(Tape 94, Side A) SB 946 - REQUIRES RETAIL DEALERS OF OXYGENATED GASOLINE TO POST LABEL OR NOTICE PRESCRIBED BY FEDERAL CLEAN AIR ACT -PUBLIC HEARING Witnesses: Roger Martin, BP Oil Ken Simila, Oregon Department of Agriculture

032 ROGER MARTIN, BP OIL: Testifies in support of the bill. Reads from written testimony (EXHIBIT A). Supports the amendments.

080 CHAIR DWYER: The federal label makes it look like these fuels are wonderful, but what does that tell me in regards to my automobile?

098 MARTIN: The big companies don't sell oxygenated fuel. Oxygenated fuels are only sold at certain times and in non-attainment areas.

119 SEN. KENNEMER: A comment about getting a quality fuel: the proof is in how it works.

135 KEN SIMILA, OREGON DEPARTMENT OF AGRICULTURE: Testifies in opposition to the bill. Introduces (EXHIBIT C).

193 MARTIN: The state law doesn't require the federal label only. It requires two labels.

202 CHAIR DWYER: He is saying there are two notices on one label. You want to amend a federal process. We are only amending the bill as it relates to the federal attainment areas.

212 MARTIN: Our attorneys say that present state law requires two labels.

215 CHAIR DWYER: Forget what your lawyer said. If you could put just one label on would you object to this format?

224 MARTIN: I'd have to ask the people that actually do the labeling.

226 CHAIR DWYER: We can tweak this bill to have the language say that one label is sufficient.

236 MARTIN: It also has to do with size.

239 CHAIR DWYER: The federal size is 36 points.

247 MARTIN: We tried to combine these earlier and we were told that we couldn't do it. This is an illustration of how easy it is to do

business in some places and how hard it is in this state.

258 CHAIR DWYER: What if it's possible to do it in one label?

262 MARTIN: We don't want to have a different label for Oregon and the rest of the country. 266 SIMILA: A California label marketer tells us it isn't a problem to use the same label.

283 RICHARD DAY-REYNOLDS, COMMITTEE ADMINISTRATOR: Roger, so one label is not what you're concerned about.

185 MARTIN: We are concerned about one label, but I don't have the information to debate this. We all have bigger things to deal with. I

concede to him.

290 CHAIR DWYER: We can pass this out and get it moving through the process and fix it along the way.

297 MARTIN: Let's have our staffs fix it and move along.

300 SIMILA: This bill comes down to the word "only" in line 32. If it stays in the bill then Oregon consumers are the losers.

354 SEN. KENNEMER: There isn't currently an attorney on the commission?

357 FINE: Yes, there is one, but they need a spare.

360 SEN. KENNEMER: What area of law do you practice?

363 FINE: I'm a legal aid attorney. My horse experience has been a life long thing. I am currently competing as an amateur in the Northwest

Hunter Association Circuit.

373 SEN. KENNEMER: Not for money, right?

376 FINE: No. I have a lot of experience with race horses. It's important to me that horse racing has a good image.

398 SEN. KENNEMER: Where are the commission meetings and can you make it to those easily?

402 FINE: In Portland, and I can make those easily.

408 CHAIR DWYER: What's the connection between the racing commission and jumping horses?

415 FINE: They aren't except that they both use horses.

418 CHAIR DWYER: Do they use thorougHB reds for jumping? 419 FINE: Yes.

427 SEN. KENNEMER: What are some of the key issues confronting

the commission?

063 FRANK BRAWNER, OREGON BANKERS ASSOCIATION: Testifies in support of the bill. Explains the amendments.

083 CHAIR DWYER: The -1 amendments accomplish what you want?

085 BRAWNER: Yes, except the effective date.

090 CHAIR DWYER: What do we have to do?

091 BRAWNER: We have to make Section 1 applicable to 94-95 tax year and make Section 2 applicable to the 93-94 tax year.

093 CHAIR DWYER: We don't have language to do that?

084 BRAWNER: I have language, but only one copy.

085 SEN. KENNEMER: Is the tax year the actual year? (Doesn't get an answer) 100 DOLORES DEVINE, OREGON ASSOCIATION OF COUNTY TAX COLLECTORS: We are in agreement with the amendments.

120 CHAIR DWYER: Hearing no objection SO ORDERED.

122 MOTION: SEN. KENNEMER moves the -1 amendments.

145 SEN. KENNEMER: Who is Don Payne.

148 DAY-REYNOLDS: Cherie was unable to get in touch with him.

152 LUCINDA POTTER, OREGON STATE MORTUARY AND CEMETERY BOARD: Testifies for Mr. Payne (Sponsor). He is trying to get some consistency in the

statute. It's unclear in statute whether a funeral director can serve

as a legal representative or not.

239 POTTER: That fee is for reissuance of license. 245 SEN. ADAMS: How much is that?

246 POTTER: 10 dollars.

247 SEN. KENNEMER: The -1 amendments only delete the word "service"?

251 POTTER: That's correct.

253 SEN. KENNEMER: Why the change?

255 POTTER: It's not commonly used language in the industry.

303 CHAIR DWYER: What kind of criticiSMwill we get if we pass this bill in regards to the Lincoln City episode?

310 POTTER: This was a tremendous consideration. Because of regular inspections we are reaching a much higher level of compliance.

330 CHAIR DWYER: Will a reduction in the annual inspections be the result of the fact that they know you won't be coming around anymore

333 POTTER: I can't answer that.

341 SEN. KENNEMER: Do you inspect cemeteries?

344 POTTER: Yes. This is new for them. 362 SEN. KENNEMER: Are some inspections based on complaints?

370 POTTER: That's correct

372 SEN. KENNEMER: All our professional licenses are for two years.

380 CHAIR DWYER: It gives them money to use for a year too.

390 SEN. KENNEMER: Most boards stagger their renewals. How much revenue does this give you?

395 POTTER: It keeps our revenues the same.

process it as an N.S.F. (Non-sufficient funds)
