004 VICE-CHAIR BUNN: Calls meeting to order at 3:15 p.m.

(Tape 75, Side A) REPORT FROM EMPLOYMENT DIVISION WITNESSES: David Allen, Employment Division Pamela Mattson, Employment Division

010 DAVID ALLEN, EMPLOYMENT DIVISION: Submits and reviews outline and report to the Workforce Quality Council and 67th Legislative Assembly,

(EXHIBITS A & B).

050 SEN. BUNN: How do we measure success if we can't measure program outcomes?

Allen: It measures success in comparison to Oregon labor market. It's

a comparative analysis, not with a control group.

SEN. BUNN: When we established this in 1991, we wanted to measure the success of some individual programs. Was that desired result unable to

be achieved?

Allen: The desired result is there. We just can't determine whether those individual programs made a difference.

SEN. BUNN: It measures the continued employment of people after they've left the programs?

Allen: Yes, it does. Continues report summary.

154 SEN. BUNN: If you're not able to measure outcomes, then how did you determine the community college training made a difference? Allen: In this case, education did make a difference. In all cases, we show differences between program participation.

SEN. BUNN: We spend a great deal of money on job training programs. We should be able to measure the result of these programs. Is there a way? Allen: We can follow the labor market outcomes of participants over time. With the exception of education, we can't measure whether those outcomes are a result of the programs.

SEN. BUNN: How can we isolate education and determine it was the cause of the outcome when we can't determine that for the other factors? Allen: Education is a part of many programs.

250 SEN. CEASE: What does that mean in terms of labor market success?

Allen: The average college graduate earns twice the income of the high school graduate and suffers half the unemployment rate.

SEN. CEASE: People get greater self-worth from education.

SEN. BUNN: Questions whether programs are working and how it can be measured.

Allen: Responds that effectiveness of programs can't be measured.

034 SEN. CEASE: Seems that what we're doing isn't enough.

SEN. BUNN: The community college programs seem to be good. Will we be able to obtain accurate information before next session on whether these programs are achieving their outcomes?

Allen: We'd be closer to having an answer.

100 SEN. CEASE: Need to be doing a better job.

SEN. BUNN: It's important to develop successful measurements. CHAIR WEBBER: Can you do some analysis on various samples? SEN. BUNN: Asks if it's possible to establish a control group so the

outcomes can be determined.

170 PAMELA MATTSON, EMPLOYMENT DIVISION: Suggests researching the questions raised by the committee and reporting back.

SEN. BUNN: Is frustrated that the Shared Information System is expected to deliver more than is possible.

CHAIR WEBBER: Requests more information on the methodology of the

report. Asks how many people are working on the project.

250 Allen: Approximately 4.25 FTE working on occupational program planning system and the automated follow-up.

Mattson: The is 5 FTE in the Shared Information System.

CHAIR WEBBER: Requests that Employments Division return in two weeks

with more information.
