330 Penny: Reviews -5, -6, -7, -8, -9 amendments and machine engrossed bill, (EXHIBITS G-L). Submits summary of bill, (EXHIBIT M).

CHAIR WEBBER: This bill puts federal regulations into Oregon statute.

There is a Senate bill that just amended the statutes to conform to the federal requirements.

375 CONNIE BULL, DEPARTMENT OF EDUCATION: Discusses purpose of bill and reasons why it's needed. Submits HB 2062 material, (EXHIBIT N). This

bill adopts FERPA with several exceptions. Submits material discussing how HB 2062 deviates from FERPA, (EXHIBIT O). House Judiciary opposed just putting FERPA into Department of Education rules rather than into the statutes. They wanted the specifics in the bill.

430 MELINDA GRIER, DEPARTMENT OF HIGHER EDUCATION: We are more and more in conflict with federal statute because our state statute is separate from it.

TAPE 79, SIDE B

043 SEN. CEASE: If we didn't do anything, then you would either be without a bill or forced to do it by rule.

Grier: We already have student records laws. We cannot adopt rules that conflict with these laws. Submits hand-engrossed bill with changes to the -4 amendments, (EXHIBIT P).

100 Penny: Reviews various policy issues discussed with her.
