Addresses the issue of runoff elections "implicit in that question is the assumption that if we, the committee, limits the choice to only two people then we'll have majority rule, and that that's the way we should do it."

329 SEN. JOHNSON: "That's not the point. n

SMITH: "But that is implicit because the context of your question is that we need to limit things if we're not going to have a runoff election. I personally am in favor of runoff elections, but I submit to you that a minority President and a minority Governor is better than having no choices at all. Which is what a lot of Americans have when they go to the polls to vote for their local candidates, every November."

339 SEN. JOHNSON: Makes a clarification statement in regards to runoff elections.
