The court appoints guardianship? 095 Brandon: Yes. 097 Sen. Cohen: Gives example of alzheimer patient who is turned down by the nursing home, then what? 100 Brandon: Responds. 117 Chair Shoemaker: Consider a situation where there is a guardian for an incapable or permanently unconscious, or terminal where death is eminent; in each of those three there is no power of attorney. You are saying in that situation we should rely on guardianship? How does that work? Someone initiates the guardianship?

189 Chair Shoemaker: Present law has guardian second in line after spouse. Are you comfortable with that order of priority?

222 Chair Shoemaker: Only if the principal is capable, at which time you would not need a guardian.

228 NANCY DOTY: Provides testimony in opposition to SB 286.

241 Chair Shoemaker: Who are you with? Do your clients include institutions?

249 Doty: Responds.

270 Chair Shoemaker: What if you have witnesses to the fact that this person is incapable?

271 Doty: Responds.

332 Sen. Cohen: What do you mean by monitoring?

377 Chair Shoemaker: You are saying that nursing homes deliberately ignore those legal requirements and have a third person create an unlawful power of attorney for health care and act upon that?

396 Doty: Gives example.

013 Chair Shoemaker: I don't think that is a good reason to change the law though.

014 Doty: We need to build in safe guards against this kind of abuse.
