098 Barbara Coombs, Administrator: Reviews the hand-engrossed copy of the A-engrossed bill, Exhibit B.

112 Chair Shoemaker: We would delete 1, 2 (3) and 3. Sen. Cohen would like to consider deleting pg. 2, lns. 9-10, (e) and (f).

124 Jean Thorne, Office of Medical Assistance Programs: Speaks to the amended A-engrossed bill, Exhibit B.

172 Sen. Smith: The testimony is that this would happen even if we voted no?

177 Thorne: Responds. 178 Sen. Smith: If this will happen without this legislation I will be voting no.

183 Chair Shoemaker: It is important that public health be integrated into the health care delivery system. I would be more comfortable in it

being an interim study than dealing with a piece of it here.

192 Sen. Hamby: Concurr. However we do have a dash 3 amendment that deals with public health.

193 Chair Shoemaker: The lottery fund? It has been moved into the bill, but I don't know if this has been reviewed with Rep. Meek.

201 Sen. Hamby: Requests the bill be held over until I check with Rep. Meek.

205 Chair Shoemaker: Let's leave it alone for now and Sen. Hamby can check with Rep. Meek to see if he is comfortable with letting the bill be a

vehicle for the dash 3 amendment. Announces a July 1 special meeting on the Washington State Health Care Plan.
