250 LEE HAZELWOOD: We can't cut school programs, or school budgets. As a senior, I vote for school levies, and anything that helps my town. When my taxes come due, I grumble a little, but I pay them. I'm willing to

pay my fair share.

261 SEN KERANS: We need to underline the point that we have a continuum of care. If we break it up, it becomes dysfunctional, and problems mount

and pile up at the end. We need to look at the context of what is going on. You pull out the little pieces, the problem doesn't go away, it

costs more later. We either pay now, or pay later.
