Disability Services Division) progress will be compromised by the Governor's Mandated Budget. There will be a group of individuals

who will inevitably lose services.

- Four specifics around the vulnerabilities: - Transfer of services and some of the costs from MHDDS

programs to the local jails and to local public safety

offices. - Domino effect - Considerable General Fund offsets from Adult and Family

Services and other DHR agencies based on legislative

decision to fund those activities in other ways. - Oregon Health Plan has the potential of pushing the Agency

back to the 17 percent level of resources

176 SEN KERANS: What do you mean about the Oregon Health Plan driving the Agency back to the 17 percent level?

179 DR. LIPPINCOT: The Oregon Health Plan is very important to the state. If, for example, we could not raise the \$100 million (present estimate) of what it would cost to get the program started, then we along with

other DHRagencies would be asked to contribute some General Fund to the development of that program. There is a long history, both in the state and across the country, of borrowing money from mental health services

to pay for other wonderful programs, but that always leaves the agency

somewhat underfunded.
