009 MOTION: SEN. KERANS: Moves the committee introduce LC 3422, LC 3620, LC 3777, LC 3803, LC 3804, LC 3806, LC 3807, LC 3808, LC

3809, LC 3810, LC 3811, LC 3812, LC 3517. EXHIBIT A. 018 VOTE: CHAIR MCCOY: Hearing no objection, it is so ordered. SEN. SPRINGER IS EXCUSED.

028 MIKE MERIWETHER, COMMITTEE ADMINISTRATOR: Gives overview of SB 142 . Introduces amendments to bill proposed by the Department of Insurance

and Finance. The Division of Vocational Rehabilitation has agreed to the amendments.

084 MIKE MERIWETHER: Introduces -1 amendments to SB 409.

094 SEN. HANNON, DISTRICT 26: Testifies in SUPPORT OF SB 409 -1 AMENDMENTS.

110 RAY GRIBLING, UNISERVE CORPORATION: Testifies in SUPPORT OF SB 409 -1 AMENDMENTS.

122 SEN. KERANS: Discusses the cap amount on line 18-19 of the bill.

134 MOTION: SEN. KERANS: Moves the adoption of the proposed hand engrossed amendments to SB 409.

141 CHAIR MCCOY: Hearing no objection, it is so ordered.

145 MOTION: SEN. KERANS: Moves SB 409 as AMENDED to WAYS AND MEANS BY PRIOR REFERENCE with a DO PASS recommendation.

147 VOTE: In a roll call vote, all members present vote AYE. EXCUSED: SEN. BRYANT, VICE-CHAIR SPRINGER.

PUBLIC HEARING, SB 483

155 SEN. LENN HANNON: Submits and summarizes testimony from EXHIBIT B in SUPPORT of SB 483.

185 RICHARD KOSESAN, OREGON ATHLETIC TRAINERS SOCIETY: Testifies in SUPPORT of SB 483.

199 SARA WILEY, CERTIFIED ATHLETIC TRAINER: Testifies in SUPPORT of SB 483 .

270 SEN. MCCOY: Will that mean that high schools and colleges will have to have someone who is a registered or certified athletic trainer?

276 RICHARD KOSESAN: It is not a requirement for any school to hire or employ a registered athletic trainer. The bill is intended solely to

register athletic trainers.

298 SEN. HANNON: Asks that the committee consider the deletion of section 10 of SB 483.

309 SEN. KERANS: On line 32, paragraph A, page 2 of SB 483, there is a constitutional problem with that piece of language.

320 SEN. HANNON: That language has already been recommended to delete. It was a drafting error.

323 SEN. KERANS: Speaks to the Fiscal statement of SB 483.

380 SEN. HANNON: Speaks to the amendments of SB 483.

389 SEN. KERANS: Section 3(2) -- Questions the need for the specific language which designates the Oregon Athletic Trainer's Society to act

as an advisory board to the Health Division.

400 RICHARD KOSESAN: The intent was to allow the Oregon Athletic Trainer's Society some input into the system. The language could be readily

amended by modifying "shall" on line 23 to "may" and add a period after the word "board" on line 24. This clears the intent to say that the

Society would have some advisory role.

413 SEN. KERANS: Suggests even broader language, saying that the Health Division may create an advisory board to the administration of this act, and may include in it representatives of the Oregon Athletic Trainer's

Society, trainers in general, public members and others.

010 SEN. KERANS: Asks the committee administrator to draft the proposed conceptual amendments which were discussed.

020 MOTION: SEN. KERANS: Moves that the committee ADOPT the conceptual amendments to SB 483.

025 VOTE: CHAIR MCCOY: Hearing no objection, it is so ordered.

027 MOTION: SEN. KERANS: Moves SB 483 as amended to the Floor with a DO PASS recommendation, and RESCIND the referral to JUDICIARY.

036 VOTE: In a roll call vote, all members present vote AYE. EXCUSED: VICE-CHAIR SPRINGER.

039 CHAIR MCCOY: It is so ordered.

053 SEN. KERANS: Asks the consideration of LC 3804 as a possible amendment to SB 174.

120 SEN. KERANS: Explains views on amending SB 174 to include the language in LC 3804.

151 MAYNARD HAMMER, EXECUTIVE DEPARTMENT: Testifies in SUPPORT of the amendments to SB 174, proposed by the Executive Department which were

faxed to staff prior to this hearing.

170 CHAIR MCCOY: What agencies do you want to privatize?

171 MAYNARD HAMMER: At this point, the privatizations would be the Oil Heat Commission, and Oregon Public Broadcasting.

174 CHAIR MCCOY: Why?

175 MAYNARD HAMMER: Responds.

215 CHAIR MCCOY: What is the mission of the Oil Heat Commission? Oregon Public Broadcasting?

218 MAYNARD HAMMER: Responds and directs the question to Brian DeForest, the Budget Analyst for these agencies.

224 BRIAN DEFOREST, BUDGET ANALYST, EXECUTIVE DEPARTMENT: Responds and continues testimony on SB 174.

239 SEN. BRYANT: Comments on the tasks of the Oil Heat Commission. Asks questions regarding their funds.

250 BRIAN DEFOREST: Responds.

270 MAYNARD HAMMER: Continues with testimony on SB 174.

280 SEN. KERANS: Would the bill be sufficient, as far as you are concerned, with the adoption of the -1 amendment?

285 MAYNARD HAMMER: Responds.

309 CHAIR MCCOY: What happens to the building, equipment, and everything else?

313 MAYNARD HAMMER: Our intent, with the possible exception of the Oil Heat Commission, is to transfer books, records, accounts, assets, etc. to the successor organization.
