005    CHAIR MCCOY:    Calls the meeting to order at 3:11 p.m. as a subcommittee.

EXECUTIVE REAPPOINTMENTS, OREGON STATE BOARD OF NURSING

014    JUDY L. COLLIGAN, RN: Gives background for the executive reappointment to the Oregon State Board of Nursing.

031    ROSARIO KAISER, RN: Gives background for executive reappointment to the Oregon State Board of Nursing.

050    KATHERINE R. SCHMIDT, RN: Gives background for executive reappointment to the Oregon State Board of Nursing.

068    SEN. KERANS:    Asks reappointees to give views on SB 174, (tabled from 3-10-93) in regard to the future of the Oregon State Board of Nursing.

076    KATHERINE SCHMIDT: Responds with comments on the umbrella agency concept.

120    CHAIR MCCOY:    Asks whether the Board investigated the umbrella concept.

123    KATHERINE SCHMIDT: Yes -- gives examples.

135 CHAIR MCCOY: Is there anyway you can construct an umbrella agency, and make it work?

139 JUDY L. COLLIGAN: We did a survey of all of the umbrella agencies, and overall, most of them would report that they are inefficient.

155 SEN. KERANS: Asks the favorite of two choices: (1) status quo plus current services level; or (2) umbrella agency.

190 REAPPOINTEES: Unanimous on the status quo plus current services level option.

218 JUDY L. COLLIGAN: Explains the administration of the State Board of Nursing, and voices her concerns about umbrella agencies.

230 KATHERINE R. SCHMIDT: Expresses that the Board is discouraged by the umbrella concept.

264 SEN. KERANS: Comments on the Tabling of SB 174, and privatization suggestions.

304 KATHERINE SCHMIDT: Continues with comments on the administration role of the Board of Nursing. Expressed hope that the legislature will find

some middle ground with the concept of semi-independent agencies.

329 JUDY COLLIGAN: Continues testimony on workload concerns.

360 CHAIR MCCOY: Do you certify the CNA's.

362 KATHERINE SCHMIDT: Yes.

364 CHAIR MCCOY: Questions problems regarding CNA's.

366 JUDY COLLIGAN: Responds.

390 SEN. KERANS: Maybe the answer is the status quo, but to provide you with a current service budget that adequately responds to the needs of

the Board in order to discharge its duties. The Board might need to look at further increasing the educational standard for potential licensees.

440 KATHERINE SCHMIDT: We have increased our licensures and certification fees over the years to try to deal with the increasing volume.

454 MOTION: SEN. KERANS: Moves the recommendation to the Full Committee the REAPPOINTMENTS of JUDY L. COLLIGAN, ROSARIO KAISER, AND KATHERINE R. SCHMIDT to the STATE BOARD OF NURSING for

confirmation.
