PUBLIC HEARING ON HB 2409

WITNESSES: Rep. Kevin Mannix, District 32 Cindy Becker, Printing Division

008 REP. KEVIN MANNIX, DISTRICT 32: Testifies in favor of HB 2409.

029 CINDY BECKER, PRINTING DIVISION: Testifies in opposition to HB 2409. -The cost could be significantly reduced if the legislation passes.

080 SEN. RASMUSSEN: Asks Becker if it would be possible to withhold the printing request until a final decision is made by the requestor (to

save the Division from having to run extra copies or discard copies made from poor planning.)

093 BECKER: States that the State agencies generally do this without legislation. 097 CHAIR SMITH: Asks Becker what the "downside" would be to passing the bill.

100 BECKER: States that the legislation is simply not necessary.

112 REP. MANNIX: Expresses concern over the Executive

Department disagreeing with the bill at this time.

004 SEN. RASMUSSEN: Asks Keizer about the residency requirement. -Believes that the State Police may be reading the bill incorrectly.

020 KEIZER: Replies that the State Trooper may be appointed if he lives outside of Oregon. -A special appointment (not a direct hire) of any trooper is what is

defined in Line 29 Page 1.

026 SEN. RASMUSSEN: Attempts to clarify that residency is not an issue because the language requiring the individual to be a state

resident has been eliminated.

070 BILL NICKLEBERRY, GENERAL SERVICES: Testifies in favor of HB 3361.

110 REP. LARRY SOWA, DISTRICT 26: Testifies in favor of HB 3361. 122 SEN. COOLEY: Asks Rep. Sowa for clarification on intent of bill.

127 REP. SOWA: Replies that the bill attempts to not have critical sections of private land sold for the public's purpose of reaching state land.

152 SEN. COOLEY: Asks if the House had difficulty with the word "public" in defining the land. -Does the interpretation include private land as well? -States that the purpose for the bill was to alleviate some tension from the private land owners who did not appreciate the public trespassing in order to gain access to state land.

261 SEN. RASMUSSEN: Asks if there are fish and wildlife habitat issues to consider.

270 REP. SOWA: Indicates that there are such issues, but these are generally covered by special interest organizations.

345 SEN. RASMUSSEN: Suggests amending the language to include the ability for public comment inside the urban areas. -Wants to limit Sub 2 to the public comment portion in order to assist

the fish and wildlife areas.

005 CHAIR SMITH: Asks Nickleberry if public comment needs to be sought if the value of the land is greater than \$100,000.

008 NICKLEBERRY: Public comment does not need to be sought if the value is under \$100,000, but it should be considered. -Continues with
