WORK SESSION ON SB 430

- 007 MOTION: SEN. RASMUSSEN: Moves to ADOPT the -2 amendments to SB 430 dated 5-6-93.
- 013 STEPHANIE HOLMES, RESEARCH COUNSEL: Reviews SB 430 and the proposed amendments.
- 014 SEN. ADAMS: States that the debate on the Floor questioned the last/best offer on either an item-by-item basis or on a package basis.
- Will this amendment be made today?

- 019 VOTE: CHAIR SMITH: Hearing no objection, the motion CARRIES. All members are present for vote.

- 035 $\,$ HOLMES: Reviews SB 760 and the reasons it was sent back to committee.
- O40 CHAIR SMITH: Discusses what the amendments do. -Amendments delete Motor Vehicles and private residences as places
- affected by the bill. -Defines a ventilation system. -Sets a penalty for offenses.
- 052 MOTION: CHAIR SMITH: Moves to ADOPT the -3 amendments to SB 760 dated
- 055 SEN. SPRINGER: Clarifies that an employer may not designate a break or lunch area as a smoking area under the amendments.
- 063 VOTE: CHAIR SMITH: Hearing no objection, the motion CARRIES. All members are present for vote.
- 066 MOTION: CHAIR SMITH: Moves SB 430 AS AMENDED to the Floor with a DO PASS recommendation.

PUBLIC HEARING ON HB 2133

WITNESSES: Pamela Mattson, Employment Division Richard Van Pelton, Employment Division

- 100 PAMELA MATTSON, EMPLOYMENT DIVISION: Presents testimony in favor of HB 2131, HB 2132 and HB 2133 (EXHIBITS C, D and E). 174 JOAN VAN ALMEN, COMMITTEE COUNSEL: Asks Mattson to explain Page 3 Lines 31-33. -Presents testimony on HB 2133 (EXHIBITS F and G).
- 192 RICHARD VAN PELTON, EMPLOYMENT DIVISION: Clarifies for the committee the figures represented. -They are in coordination with the figures for unemployment.
- 235 VAN ALMEN: Asks Mattson if the Division stays with the program, the schedule will in fact be what is hoped and predicted.
- 239 MATTSON: The program will continue until 1993 for emergency unemployment. -After October 1993 the Division will govern the program pending on the unemployment rates.

295 MOTION: SEN. SPRINGER: Moves HB 2133 to the Floor with a DO

PASS recommendation.

- 297 VOTE: In a roll call vote, all members present vote AYE. SEN. ADAMS is EXCUSED.
- 298 CHAIR SMITH: The motion CARRIES.
- 300 SEN. SPRINGER will lead discussion on the Floor.

RE-OPEN WORK SESSION ON SB 760

- 306 MOTION: SEN. RASMUSSEN: Moves SB 760 AS AMENDED to the Floor with a DO PASS recommendation.
- 308 VOTE: In a roll call vote, all members present vote AYE with the exception of SEN. COOLEY and ADAMS who vote NO.
- 310 CHAIR SMITH: The motion CARRIES.
- 312 SEN. RASMUSSEN will lead discussion on the Floor.
- 320 SEN. COOLEY: States that he and Sen. Adams will file and support a minority report.

PUBLIC HEARING ON HB 2131

WITNESSES: Pamela Mattson, Employment Division Richard Van Pelton, Employment Division

350 PAMELA MATTSON, EMPLOYMENT DIVISION: Reviews bill and position of the Employment Division. -Refers to EXHIBIT F.

TAPE 159, SIDE A

- 003 MATTSON: Continues with testimony. -Has proposed language in cooperation with the ACLU that have to do with disclosure of information.
- 048 CHAIR SMITH: Inquires about how the agency determines that an exception to the disclosure law is appropriate. -Are they going to adopt administrative rules regarding this matter to

assign criteria for determining an exception?

- 065 MATTSON: The decision is made by an administrator and the final decision is signed by Mattson. -There is a management team and an advisory council determining how the information is to be distributed or released. -The policy and procedures are clear within the Division.
- 134 JOAN VAN ALMEN: States that Mattson has not clarified in past discussions how the exchange of information will take place under the

rule of confidentiality.

- 170 CHAIR SMITH: Asks Mattson if the bill passes, will the Division electronically transfer the information throughout other agencies.
- 181 MATTSON: Replies that they would not with the exception of

information that is not generally considered to be confidential. -The information is mostly if the aggregate type rather than personal

information about an individual. -Under this legislation, we could continue to have electronic access to information.

- 226 SEN. ADAMS: Asks if there are currently problems with the information system regarding confidentiality.
- 230 MATTSON: Implies that there are none.
- 250 SEN. ADAMS: Asks Mattson why the language regarding specific agencies are to be removed.
- 256 MATTSON: Replies that this has been done at the request of the ACLU to maintain confidentiality. -Premise is to keep information confidential.
- 386 VAN PELTON: States that identification of clients will come through either their signature or a Personal Identification Number (PIN).

TAPE 158, SIDE B

002 MATTSON: States that the employers appreciate the flexibility of the Division and how information is accessed. -Local governments can request the return of excess funds to budget

unemployment costs. -We are trying also to end the practice of double notification between $\$

the employer and the Division. –To summarize, settlements $% \left(\frac{1}{2}\right) =0$ are monitored to ensure that there is no

"double dipping" i.e., the parties are not reimbursed twice. The bill

keeps the Division in coordination with federal requirements. -There is a penalty tax rate to the employer for tardiness in paying

unemployment. The bill also strives for technological advances in information access.
