180 JIM SCHERZINGER continued with Major Revenue Issues for House and Senate. Exhibit 3.

188 SEN. JOHNSON inquired about the origination of tax reform resolutions in the Senate to go directly to the people.

192 JIM SCHERZINGER clarified the difference between bills and resolutions and confirms that a tax reform resolution can be initiated by the Senate. Discussion.

257 JIM SCHERZINGER continued. He explained that the Revenue Committee will deal with the immediate issues before the committee until tax reform discussion begins. Then tax reform issues will take precedence. The Senate Committee will begin with Property Tax and Urban Renewal. The immediate bills before the Committee are those that deal with the implementation of Measure 5 and the property tax system.

313 JIM SCHERZINGER then went over the current House schedule of issues which include the income tax system, administration bills, timber tax issue, and the sunset of the historic property statute. Questions and discussion.
