Exhibit 1. 120 TERRY DRAKE pointed out that the user based system which is based primarily on weight causes the larger trucks to be taxed at one of the highest rates in the nation. 140 TERRY DRAKE informed the Committee that the price on fuel, not considering inflation, is at the lowest rate since the early 1970's or even late 1960's. 170 TERRY DRAKE reminded the Committee that revenue from the gas tax is constitutionally dedicated to the Highway Fund. 190 TERRY DRAKE explained the distribution of the Highway Fund. 252 SEN. ADAMS inquired about the correlation on the weight mile tax and the vehicle registration license fee to the business cycle. 243 TERRY DRAKE responded that this correlation was not coincidental. He pointed out that this entire system runs on the growth of population and business/commerce. Questions and discussion interspersed. Exhibit 2. 140 JIM SCHERZINGER recapped the answers to several specific questions that were not covered in the packet of material. 147 JIM SCHERZINGER stated that Certificates of Purchase (COPs) are not included in local district bond limitations. 154 JIM SCHERZINGER related that 13% of seniors eligible for the Senior Deferral program participate in that program. 211 JIM SCHERZINGER informed the Committee that the number of Oregonians who had tax return incomes above the \$70,000 range were 5% of individual filers and 10% of married filers. 240 JOHN LATTIMER began testimony regarding the fiscal office's analysis of the Governor's budget. Exhibits 3 & 4. 300 JOHN LATTIMER pointed out that the growth of the Oregon State Budget follows very closely to population growth and the consumer price index (CPI). 330 JOHN LATTIMER spoke about Measure 5 and the origin of discontentment that occurred just prior to its passage regarding the cuts in property tax relief. 355 JOHN LATTIMER stated that the medical CPI is growing quite dramatically. This is important because one of the fastest growing areas of the budget is the medicaid/medical services budget in the Department of Human Resources (DHR). 365 JOHN LATTIMER pointed out the rapidly rising costs of a portion of the population that requires more extensive funding. 380 SEN. JOHNSON inquired about information regarding retirees on fixed incomes from other states. 405 JOHN LATTIMER concurred that a number of retired citizens dispose of their resources so that the state will provide for them. 420 SEN JOHNSON inquired about other "retired" states' experiences with this situation. Questions and discussion. 120 JOHN LATTIMER summarized how the Governor proposes to close the 1.26 billion dollar gap in the budget. 150 JOHN LATTIMER pointed out that programs in the proposed budgets are reduced by one billion dollars. 195 JOHN LATTIMER stated that approximately 3000 state budgeted positions will be terminated. Furthermore, the budgeting of vacancies is no longer going to be done. This will reduce the flexibility of using those vacancies to obtain additional revenue. Ouestions and discussion. TAPE 12 SIDE B 001 JOHN LATTINER continued with his testimony regarding the Governor's mandated budget. Ouestion and discussion. 160 JOHN LATTIMER went over a budget comparison sheet. Exhibit 4. 210 JOHN LATTIMER summarized Governor Roberts' top priorities. 230 JOHN LATTIMER discussed the DHRprograms and caseloads. 288 JOHN LATTIMER addressed the issue of medical assistance/costs and their impact on he budget process. He highlighted the increasing costs at dramatic rates. He concluded that like the nation, until this area of spending is under control it will be difficult to get the budget under control.
