004 CHAIR GOLD called the meeting to order at 1:15 p.m.

008 JIM SCHERZINGER testified regarding Tax Credit Criteria. Exhibits 1-7.

065 REP. JONES spoke to the Committee about working in concert with one another. She stated that the House has discussed the issue of tax credits in the income tax subcommittee and tax exemptions in the property tax subcommittee. They have developed a set of questions for making decisions regarding exemptions and credits in order to determine what she termed "solid and beneficial public policy".

112 REP. JONES discussed the possibility of rescinding some current tax credits and using the gained revenue to replace funding for other credits or exemptions.

Questions and discussion.

125 REP. JONES said that eliminations of some exemptions and credits will commence in the near future. She stated that in some cases the bills will be allowed to sunset.

145 JIM SCHERZINGER resumed testimony regarding the list of questions that should be addressed as each credit or exemption is considered by this Committee. Exhibit 1.

380 JIM SCHERZINGER discussed the three courses of action that this Committee could take in response to this issue: 1) look at specific credits and exemptions and make recommendations 2) make a statement of policy about the criteria that should be followed and/or 3) develop a process for periodically reviewing these credits and exemptions. Questions and discussion. TAPE 55 SIDE A 001 JIM SCHERZINGER continued with his discussion on the possibility of making the analysis of credits and exemptions a legislative priority in future sessions. Questions and discussion. 053 JIM SCHERZINGER explained that if some exemptions were terminated it would increase the number of dollars available to that local school district and would reduce the amount of obligation of the State. Questions and discussion. 122 SEN. ADAMS questioned whether or not it was an efficient use of this Committee's time to address exemptions and credits of "insignificant" dollar amounts. 130 JIM SCHERZINGER responded that there is value in looking at these issues. He stated that some exemptions are growing rapidly and do not yet show the true amount in question. Questions and discussion. 162 SEN. ADAMS questioned again the insignificant amounts of some of these exemptions. He stated that if the focus was financial impact and not housekeeping, the list could be significantly reduced. 185 JIM SCHERZINGER stated that the House has considered using the cost of the credit or exemption as a criteria. 225 SEN. ADAMS reiterated his feeling that perhaps this issue should be more focused on financial impact. 245 JIM SCHERZINGER resumed his discussion of Tax Expenditure Reports and Budgets. Exhibit 2.
