070 STEVE BENDER outlined the concept of an equal tax. He explained that this proposal would eliminate the existing state and local taxes and fees and establish in lieu a 2% tax on all trade within the state and trade between Oregon persons and persons outside the state.

095 JIM SCHERZINGER testified briefly regarding the 2% Equal Tax. He explained that when he analyzed this proposal, he examined the issues that a legislative body should think about when considering this proposal. He also studied the issue to determine if the specific language of the measure achieved what he perceived to be its intent.
