008 CHAIR ROBERTS: Discusses changes on the rules (EXHIBIT A).

012 JAYME ARMSTRONG, COMMITTEE ADMINISTRATOR: Reiterates the
changes.

024 SEN. HANNON: Asks about Special Session rules and Interim rules.

032 CHAIR ROBERTS: Clarifies the difference between the two sets of
rules. Returns to amendments of the Interim Rules (EXHIBIT A).
-Reconsideration issues. -Strike out the first sentence in subsection
(5). -Refers to pgs. 30-31 regarding the filing of drafts with
Legislative

Counsel.

090 TOM CLIFFORD, LEGISLATIVE COUNSEL: States that the date need not
be in statute in order to facilitate the drafting of measures.
-Pre-Session filing date is practical for new members. They may still
file new measures after indicated deadline.

120 ARMSTRONG: States that Legislative Counsel has suggested the
same change in section 213.07, subsection (1), substituting "measure"
for

"request". -Would be consistent with other changes made.

141 SEN. HANNON: Questions whether all pre-Session filing should be done on the same date. -Refers to pg. 30, section 213.07, subsection (3).

158 DONNA MERRILL, SECRETARY OF THE SENATE: Clarifies that section 213 .07 has a statutory requirement.

165 MOTION: SEN. HANNON: Moves to ADOPT the draft Interim Senate Rules dated 7-1-93.

170 VOTE: CHAIR ROBERTS: Hearing no objection, the motion CARRIES. SEN. TIMMS is EXCUSED.

174 CHAIR ROBERTS: Adjourns the meeting at 11:00 a.m.
