005 CHAIR ROBERTS: Calls the meeting to order at 12:33 p.m.

WORK SESSION - DISCUSSION OF PROPOSED AMENDMENTS TO THE TEMPORARY RULES
OF THE SENATE

CHAIR ROBERTS: Asks members to review the proposed amendments from
(EXHIBIT A). Discusses the amendment to section 8.43 of the temporary
rules of the Senate.

011 SEN. JIM BUNN: Will vote no on the amendment to section 8.43.
Feels clarification is needed.

013 CHAIR ROBERTS: Addresses Senator Bunn's concern.

MOTION: CHAIR ROBERTS: Moves to amend section 8.43 by striking out
the language, "with specific instructions" and inserting the
language, "with recommendations" to the temporary rules of the
Senate.

VOTE: In a roll call vote, SENS. DUKES, HANNON, TIMMS, TROW,
SPRINGER, AND CHAIR ROBERTS vote AYE. SEN. BUNN votes NO.

025 CHAIR ROBERTS: The motion is adopted.

026 CHAIR ROBERTS: Discusses the amendment to section 8.20 from
(EXHIBIT A).

MOTION: CHAIR ROBERTS: Moves to adopt the amendment to section 8.20 to the temporary rules of the Senate.

VOTE: In a roll call vote, SENS. BUNN, HANNON and TIMMS vote AYE.

SENS. DUKES, TROW, SPRINGER and CHAIR ROBERTS vote NO.

CHAIR ROBERTS: The motion fails.

054 CHAIR ROBERTS: Discusses the amendment to section 4.01 from (EXHIBIT A).

MOTION: CHAIR ROBERTS: Moves to amend section 4.01 of the temporary rules of the Senate, striking the reference to the "Flag Salute" to read "Honors to the Colors".

DISCUSSION TO THE MOTION:

064 SEN. BUNN: Wants to know the reason for deleting "Flag Salute"?

066 CHAIR ROBERTS: To offer flexibility in ceremonials during the opening of a floor session.

VOTE: In a roll call vote, SENS. DUKES, TROW, SPRINGER and CHAIR ROBERTS vote AYE. SENS. BUNN, HANNON AND TIMMS vote NO.

CHAIR ROBERTS: The motion carries.

085 CHAIR ROBERTS: Discusses Sen Bunn's amendment on section 8.30 from (EXHIBIT B). 117 SEN. LENN HANNON: Wants to know why this language is needed?

141 SEN. BUNN: Feels that there are some misunderstandings about what a committee of the whole can do.

169 SEN. DICK SPRINGER: Does not feel that this language is necessary. It confuses an issue which is relatively clear.

MOTION: CHAIR ROBERTS: Moves to amend section 8.30 of the temporary rules of the Senate.

VOTE: In a roll call vote, SENS. BUNN, HANNON and TIMMS vote AYE.

SENS. DUKES, TROW, SPRINGER and CHAIR ROBERTS vote NO.

CHAIR ROBERTS: The motion fails.

MOTION: CHAIR ROBERTS: Moves that the rules, as amended, be adopted to the Senate Rules committee.

VOTE: In a roll call vote, SENS. DUKES, HANNON, TROW, SPRINGER and ROBERTS vote AYE. SENS. BUNN and TIMMS vote NO.
