000 CHAIR COHEN: Convenes meeting at 8:00 a.m.

HB 3658A - EDD Reorganization - Work Session

010 JOSEPH CORTRIGHT: Overviews Proposed -A10 (EXHIBIT A), -A11 (EXHIBIT B), and -A12 (EXHIBIT C) Amendments.

070 CORTRIGHT: Begins overview of Proposed -A9 Amendments (EXHIBIT D) and list of issues (EXHIBIT E).

210 BILL SCOTT: Testifies regarding proposed -A9 Amendments and policy issues of concern to the Executive Branch (EXHIBIT F).

284 MOTION: SEN. RASMUSSEN MOVES to add the words "estimates of" after the word "include" on Page 3, Line 24 of the printed A-Engrossed version of HB 3658.

VOTE: PASSES, without objection. EXCUSED: SEN. GOLD and SEN. HAMBY.

Committee begins section-by-section discussion of Proposed -9 Amendments.

SEN. KENNEMER: The Commission should be strictly a policy-making body, not administrative.

MOTION: SEN. RASMUSSEN MOVES that the words "the Commission and" on Page 2, Line 32 of the A-Engrossed version of HB 3658 be deleted.

VOTE: PASSES, without objection. EXCUSED: SEN. HAMBY.

Committee discussion regarding language proposed for Subsection (3) on lines 3 through 9, Page 2 of the Proposed A9 Amendments to HB 365 8A and Subsection (3) on lines 13 through 15 on page 3 of the Printed A-Engrossed version of HB 3658.

400 SEN. KENNEMER: Suggests language, "The Commission shall have general power to set policy and monitor programs."

409 BILL SCOTT: SEN. KENNEMER's language is okay; but we would prefer the language in the Proposed -A9 Amendments.

MOTION: SEN. KENNEMER MOVES adoption of language that deletes language on Line 5, Page 3 of the printed A-Engrossed version of HB 3658 "have general power to coordinate and administer" and inserts language "set policy for and monitor".

VOTE: PASSES, without objection.

MOTION: CHAIR COHEN MOVES to delete Line 3 on Page 1 of the Proposed -A9 amendments. (This amendment would coordinate with action taken above.)

VOTE: PASSES, without objection.

TAPE 150, SIDE A

050 CORTRIGHT: Continues presentation of Proposed -A9 Amendments.

125 REP. GENE DERFLER: I would support the addition in the Proposed -A9 Amendments (after Line 16 on Page 2) of language that was removed from Page 3, Line 15 of the A-Engrossed version of HB 3658 that relates to actual or anticipated return on investment of public funds.

REP. TED CALOURI: Agrees with SEN. KENNEMER's point on alternatives to barriers.

MOTION: SEN. KENNEMER MOVES to insert a new subsection on Page 2 of the Proposed -A9 Amendments, on Page 2, after Line 22, as follows: "(d) Recommendations for removing identified barriers and additional suggestions for improving the performance of Oregon's economy.

VOTE: PASSES, without objection.

162 MOTION: SEN. MOVES to add language on Page 2, after Line 16 of the Proposed -A9 Amendments as follows: (D) The actual or anticipated return on investment of public funds.

VOTE: PASSES, without objection.

Committee discussion regarding policy-setting ability of the Commission and rule-making ability of the Department.

355 MOTION: CHAIR COHEN MOVES to add conceptual language that the Economic Development Commission sets policy and that the Economic Development Department writes the rules.

408 VOTE: PASSES, 6-1. VOTING NAY: SEN. KENNEMER.

410 SEN. HAMBY: What is meant by "standards" in lines 23 and 24 on Page 7 of the A-Engrossed version of HB 3658?

CORTRIGHT: Responds.

MOTION: CHAIR COHEN MOVES that Section 17(2) in the A-Engrossed version of

HB 3258 to Section 13 so that they only appear in ORS 285.025.

VOTE: PASSES, without objection.

TAPE 149, SIDE B

045 CORTRIGHT: There are some "bodies" like the Arts Commission that are attached to the Department.

052 CHAIR COHEN: The powers of those have not been delegated to the Commission.

SEN. RASMUSSEN: Identify those in statute.

CHAIR COHEN: Directs staff to determine in discussion with legislative counsel the best way to accomplish that.

Continued discussion.

070 CORTRIGHT: Continues overview of the Proposed -A9 Amendments. Discusses minor amendments on Page 3 relating to touriSMand ports.

MOTION: CHAIR COHEN MOVES adoption of language on Page 3 of the Proposed -A9 amendments relating to tourism/ports.

VOTE: PASSES, without objection.

085 CORTRIGHT: Overviews Sections 66 through 70 - language that would incorporate SB 969 into this bill.

MOTION: CHAIR COHEN MOVES to adopt language in the Proposed -9 Amendments that would incorporate SB 969 - Sections 66 through 70.

VOTE: Passes, without objection.

MOTION: CHAIR COHEN MOVES to delete references in Sections 73, 75, and 77 that relate to feasibility study for industrial modernization.

142 VOTE: PASSES, without objection.

MOTION: CHAIR COHEN MOVES adoption of language included in Page 5, line 21 through Page 11, line 26 that relate to industrial modernization (insertion of SB 284).

158 VOTE: PASSES, without objection.

MOTION: CHAIR COHEN MOVES adoption of Pages 11 and 12 of the Proposed -A9 Amendments relating to the transfer of the Arts Commission.

VOTE: PASSES, without objection.

169 CORTRIGHT: Overviews Pages 12 and 13 of the Proposed -A9 Amendments, Section 80, referring to language contained in SB 85.

MOTION: CHAIR COHEN MOVES adoption of language relating to SB 85 included in Section 80 of the Proposed -A9 Amendments.

VOTE: PASSES, without objection.

CORTRIGHT: Overviews remaining technical amendments.

170 MOTION: CHAIR COHEN MOVES adoption of technical amendments.

VOTE: PASSES, without objection.

212 MOTION: SEN. HAMBY MOVES adoption of the Proposed -A9 Amendments, as amended by committee action.

VOTE: PASSES, without objection.

223 MOTION: SEN. RASMUSSEN MOVES adoption of the Proposed -A10 Amendments .

VOTE: PASSES, 6-1. VOTING NAY: SEN. KENNEMER.

299 MOTION: SEN. MOVES SB 3658A, as amended, to the Senate Floor with a Do Pass recommendation.

VOTE: PASSES, 7-0.

340 KEVIN CONCANNON: Begins testimony on HB 2459. Submits charts (EXHIBIT G).

044 SANDY HOBACK: Testifies on operation of HB 2459.

068 KEVIN CONCANNON: Continues testimony on HB 2459.

118 PAMELA MATTSON: Testifies on operation of HB 2459, relating to unemployment insurance.

MATTSON: It is not our intent to force highly skilled workers into substandard employment.

BILL EARLY: Testifies in support of HB 2459. We have tried to keep faith with the voters and this bill is a much more improved version of Measure 7, passed at the last General Election. 210 Committee discussion.

274 EARLY: Suggests language "not be used to replace regular employees"

280 SEN. RASMUSSEN: This language does not prevent business from reorganization.

300 SEN. KENNEMER: How do you respond to the labeling of this as a "slavery" bill?

CONCANNON: I think is something that needs to be tried. It is not perfect. The status quo does not offer these opportunities. This is a pilot that will be reviewed by the state and the federal government. We don't want to hurt children or families; we want to try something to help people out of poverty.

354 CHARLES SHEKETOFF: Presents written testimony in opposition to HB 2459 (EXHIBIT H) and the Proposed -12 Amendments (EXHIBIT I).
