CHAIR COHEN: Discusses issues regarding SB 1130 and HB 3422 - Reinventing Government Act.

SEN. KENNEMER: Discusses the issue of flexibility.

MOTION: CHAIR COHEN MOVES ADOPTION OF SB 1130C as an amendment to HB 3422.

VOTE: PASSES, without objection. EXCUSED: SENATORS HAMBY and LIM.

MOTION: SEN. MOVES that language in Section 13(4) on Page 6 of EXHIBIT B as indicated by the hand-engrossment be restored.

VOTE: PASSES, without objection. EXCUSED: SENATORS HAMBY and LIM.

YOUNG: Overviews Page 7 of EXHIBIT B.

MOTION: CHAIR COHEN MOVES to adopt language in Section 13(c)(1) on Page 7 of EXHIBIT B as indicated by the hand-engrossment.

VOTE: PASSES, without objection. EXCUSED: SENATORS HAMBY and LIM.

YOUNG: In Section 13(c)(2) on Page 7 of EXHIBIT B, Line 33 should read "adequacy of" rather than "agency."

MOTION: CHAIR COHEN MOVES to adopt language in Section 13(c)(2) on Page 7 of EXHIBIT B as indicated by the hand-engrossment.

VOTE: PASSES, without objection. EXCUSED: SENATORS HAMBY and LIM.

128 YOUNG: Overviews Page 11 of EXHIBIT B.

MOTION: CHAIR COHEN MOVES to adopt language in Section 15(b) on Page 11 of

EXHIBIT B as indicated by the hand-engrossment.

VOTE: PASSES, without objection.

SENATOR HAMBY and SENATOR LIM entered meeting at this point.

146 SEN. WEBBER: The 10 percent transfer ability was an issue in the House and I would not like this to jeopardize the bill. Would we be able to reduce this percentage?

156 DAN SIMMONS: Yes.

170 MOTION: SEN. WEBBER MOVES that the amount of 10 percent in Line 33 on Page 2 of EXHIBIT C be changed to 2 percent.

VOTE: PASSES, without objection.

190 CAROLYN YOUNG: Overviews the changes that applied to SB 167 (hand-engrossed version of SB 167 submitted as EXHIBIT D) and 3 pages from House Amendments to SB 167 B submitted as EXHIBIT E.

GEOFF GUILFOY: We support these amendments.

218 MOTION: SENATOR HAMBY MOVES adoption of EXHIBIT D as an amendment to HB 3422.

VOTE: PASSES, 6-1. VOTING NAY: SEN. KENNEMER.

233 MOTION: SEN. HAMBY MOVES HB 3422 to the Senate Floor with a

Do Pass recommendation, with the understanding that this action will not be necessary if the Conference Committee meets and passes SB 1130.

VOTE: Passes, 6-1. Voting NAY: SEN. KENNEMER.
