000 CHAIR COHEN: Convenes meeting at 8:10 a.m.

SB 282 - Oregon Quality Award - Work Session

005 JOE CORTRIGHT: Overviews SB 282 and reviews previous concerns of the committee. Overviews proposed -1 amendments to SB 803 (EXHIBIT A).

026 BOB BAUGH: Comments on amendments worked out with OEDD

MOTION: SEN. BUNN MOVES to adopt the proposed -1 amendments to SB 282.

VOTE: There being no objection, the amendments are adopted.
Excused: SEN. BRADBURY and SEN. HAMBY.

MOTION: SEN. BUNN MOVES SB 282, as amended above, to the Senate Floor with a Do Pass recommendation.

VOTE: Passes, 7-0. All members present voting AYE. Excused: SEN. BRADBURY and SEN. HAMBY.

SB 803 - ORTDC Privatization - Work Session

055 CORTRIGHT: Reviews issues and questions the committee discussed on SB 803 .

069 WENDY ROBINSON: The Tort Claims Act coverage will cover the officers and employees of the Oregon Resource and Technology Development Fund but will never cover the management group.

100 WAYNE EMBREE: Discusses questions the committee had on the amendments. There is no cross-over between the Board of Directors of the ORTDC and the private fund. That would create a conflict of interest.

129 ROBINSON: Clarifies the relation between the members of the Board of the Directors and the private fund.

148 ROBINSON: Overviews -1 amendments (EXHIBIT B).

191 MOTION: CHAIR COHEN MOVES the adoption of the proposed -1 amendments to SB 803.

VOTE: There being no objection, the proposed -1 amendments are adopted. Excused: SEN. BRADBURY, HAMBY, and WEBBER.

MOTION: CHAIR COHEN MOVES the adoption of the proposed -2 amendments (EXHIBIT C) to SB 803.

VOTE: There being no objection, the proposed -2 amendments are adopted. Excused: SEN. BRADBURY, HAMBY, and WEBBER.

210 SEN. LIM: Where does the \$10 million go after privatization, and can we get it back?

212 EMBREE: Yes, we can. The only changes in terms of revenue have to do with changes in titles. The money is never taken out of public control.

233 SEN. LIM: What happens when companies default -- how do we get the money back?

CHAIR COHEN: It won't be any different than now. ORTDC needs to discuss this with you.

078 J.D. HOYE: Overviews sections on SB 1076 that the previous panel discussed.

094 SEN. GOLD: It would be helpful to have a table showing the bill's changes from what's now in statute.

114 SEN. BUNN: There are several sections of the bill that amendments are being worked on.

131 BOB BAUGH: Overviews workforce discussions/policy and SB 1076.

246 CAM BRALEY: Testifies in support of SB 1076.

269 BAUGH: Federal funds are becoming available for these types of programs.

300 SEN. BUNN: Is there flexibility for us to link up with federal funds?

340 LIZ WORMAN: Testifies in support of the Workforce Quality Council and SB 1076.

390 SEN. HAMBY: What percent of your region is business and industry?

WORMAN: Approximately 50 percent. Will get information on representation.

SEN. HAMBY: There's a difficulty in getting business participation.

WORMAN: Not a problem for us.

444 JOAN PASCO: Testifies in support of SB 1076 and regional workforce development.

068 CHAIR COHEN: If you need to hear more specifically from the programs, we need to know so that we can schedule that testimony.

SB 755 - Lottery Allocation - Work Session

092 CORTRIGHT: Overviews SB 1076/SB 755 duplicate sections:
-Targeted Training is in Section 16 of SB 755 and in Section 22 (30) of SB 107 6. -WFQC is in Sections 18, 19, and 20 in SB 755; not exactly the same in Section 22, subs 32, 33, and 34 of SB 1076. -The last duplication is Section 21 in SB 755 (Dislocated Worker Training), and subsection 10, of SB 1076. -Also Section 15, SB 755 (Industrial Modernization) also duplicated in subs 31 of SB 1076.

150 CHAIR COHEN: Any discussion on where these appropriations should be included?

BAUGH: All should be in the workforce bill - they were all included in the Governor's original \$125 million budget.

175 CORTRIGHT: Issues regarding Governor's budget. Does the committee want to leave it general or do a more detailed breakout? In many cases the only policy statement governing the expenditure of funds is included in these two bills.
